



## UPSC To Implement Facial Recognition And AI Savitribai Phule Pune University Announces **Surveillance For Exams**



The Union Public Service Commission (UPSC) of India is set to introduce facial recognition and artificial intelligence (AI) surveillance technologies to enhance the security and integrity of its examination process. This move aims to prevent impersonation and other forms of malpractice by accurately identifying candidates at exam centers.

Facial recognition technology operates by capturing and analyzing the unique features of a person's face, then matching these against a preexisting database to verify identity.

Alongside this, AI surveillance will monitor exam centers through cameras, providing realtime alerts on any suspicious activities. This integration is expected to significantly bolster the credibility of the examination process .Despite the anticipated benefits, there are notable concerns regarding privacy and potential biases. Critics point out that facial recognition systems can produce false positives and negatives, potentially impacting innocent individuals. Furthermore, the extensive data collection involved in such technologies raises significant privacy issues. Advocates emphasize the need for clear regulatory frameworks and robust privacy protections to balance the use of these technologies with the rights of individuals .

This initiative by the UPSC reflects a broader trend in India where various governmental and security agencies are increasingly adopting facial recognition and AI technologies for enhanced surveillance and security.

## Centre Ousts Exam Body Chief, CBI To Investigate NEET-**UG** Irregularities

Amid Protests Nationwide And Criticism From The Opposition, The Centre Has Removed Subodh Kumar Singh, The Chief Of The National Testing Agency (NTA), Following Allegations Of Irregularities In NEET-UG And The Cancellation Of The UGC-NET Exam. The Ministry Of Personnel Announced On Saturday That Retired Indian Administrative Service (IAS) Officer Pradeep Singh Kharola Will Take Over As The Director General Of The NTA. Kharola, Currently The Chairman And Managing Director Of The India Trade Promotion Organisation, Will Hold This Position Until A Permanent Appointment Is Made. This Decision Coincides With The Establishment Of A Committee Tasked With Recommending Improvements For The Agency. It Also Precedes The Retesting Of Approximately 1,500 NEET-UG Students Who Received Grace Marks. The CSIR UGC NET Exam, Initially Set For June 25-27, Was Postponed Due To "Logistical Reasons," And The NEET-PG Exam Scheduled For Sunday Was Rescheduled At The Last Minute On Saturday.



Additionally, The Government Has Handed Over The Investigation Into The Alleged NEET-UG Paper Leaks And Other Irregularities To The CBI. This Includes The Leaks That Caused The UGC NET Exam Cancellation.

## Maharashtra State to Conduct Additional Entrance Test **Round for BMS, BBA, BCA, and BBM Programs**

Maharashtra state is set to conduct an additional round of entrance tests for Bachelor of Management Studies (BMS), Bachelor of Computer Application (BCA), Bachelor of Business Management (BBM), and Bachelor of Business Administration (BBA) programs due to they appealed for another opportunity to take the requests from students and parents. This decision follows the initial test on June 29, which many missed due to lack of awareness. Previously, admission to these undergraduate courses relied solely on Class 12 results. However, this year, the state introduced an entrance test and centralized admission process (CAP) for these programs categorized as 'professional'

by the All India Council for Technical Education (AICTE).

Many students, unaware of the new process, found themselves unable to secure admission based on Class 12 results alone. Consequently, entrance test. The state CET Cell agreed to the additional session after consulting with the government, although the new test schedule is yet to be announced.

This move aims to fill approximately 1.08 lakh seats available across state colleges for these programs. Despite 53,748 registrations, only 48,135 students appeared for the exam, indicating potential vacancies.

#### Education Minister Dharmendra Pradhan Takes **Responsibility for NEET Errors, Establishes High-Level** Panel

acknowledged irregularities in this year's NEET undergraduate exam, specifically in Bihar, and announced the formation of a high-level committee to address these issues within the National Testing Agency (NTA). This marks a shift from his earlier stance denying evidence of a paper leak.

Pradhan accepted "moral responsibility" for the situation, noting that preliminary evidence from Bihar Police indicates the irregularities were confined to certain areas and may not require a nationwide retest. One option being considered is a retest for affected test centers only.

He emphasized the need to maintain quality and transparency, assuring strict action against those responsible, including NTA officials if necessary. Pradhan ruled out a nationwide cancellation of NEET, arguing that it would unfairly impact retest scheduled for June 23 for 1,563 candidates many students, especially those from rural areas.

Education Minister Dharmendra Pradhan has Approximately 24 lakh students took the NEET exam this year. The government is awaiting further information from Bihar Police before deciding on NEET-UG 2024 and potential retests. Pradhan explained the difference in handling the NEET-UG and UGC-NET cases, stating that the latter's cancellation was based on concrete evidence of a paper leak on the dark web. The government promptly canceled UGC-NET and initiated a CBI inquiry upon confirming the leak. On the high-level committee, Pradhan said it would include experts from various fields and would be announced soon. He also mentioned that the Law Ministry is working on framing rules for the Public Examinations (Prevention of Unfair Means) Act.

> Finally, Pradhan clarified that ongoing developments would not affect the NEET-UG impacted by errors at six centers in Haryana.

## Government Introduces Tough New Law to Combat **Exam Fraud**

In a decisive step to tackle the issue of exam paper leaks and cheating during public examinations, the government unveiled the Public Examinations (Prevention of Unfair Means) Act, 2024 on Friday. This legislation is enacted amidst ongoing controversies surrounding exams like NEET and UGC-NET, plagued by accusations of paper leaks and other irregularities.

The Act aims to prevent unfair practices in public exams conducted by major bodies such as UPSC, SSC, railways, banking recruitment exams, and NTA. Key Highlights of the Act:

1. Harsher Penalties: Individuals involved in leaking exam papers or manipulating answer sheets face a minimum three-year prison term, extendable to five years, and fines up to Rs 10 lakh.

2. Serious Offences: All offences under the Act are deemed cognisable and nonbailable, allowing authorities to arrest suspects without a warrant, and barring them from automatic bail.

3. Accountability for Providers: Service providers aware of potential

malpractice but failing to report it can be fined up to Rs 1 crore.

4. Targeting Organized Crime: The law takes a tougher stance against organised cheating. Senior officials within service providers implicated in such activities face a prison term of three to 10 years and a fine of Rs 1 crore.

5. Protection for Innocents: The Act offers safeguards to individuals who can prove they were unaware of the offence and took steps to prevent it.

The NEET and UGC-NET exams, crucial for medical and academic careers, have been particularly affected. NEET, conducted with about 24 lakh candidates, faced allegations of paper leaks, notably in Bihar. Meanwhile, UGC-NET was entirely cancelled due to suspected compromises in exam integrity.

Against this backdrop, the NTA announced the postponement of the June edition of Joint CSIR-UGC-NET, citing logistical issues and unavoidable circumstances. This exam is pivotal for determining eligibility in junior research fellowships, assistant professorships, and PhD admissions in science disciplines.

The first round of quota admissions (in-house and management) also concluded on Friday. Colleges have been instructed to display their quota vacancies and submit any remaining vacant seats to

the centralised admission rounds if they are not participating in the second round of quota admissions.

"The first round of quota admissions is complete. Colleges were directed to prepare a merit list, and students were asked to confirm their admissions between June 18 and 21," said Rajendra Ahire, Deputy Director of Education, Pune Division. No grievances or corrections were reported during the June 18 to 21 period for checking the status of applications in the provisional merit list.





## Canada: Work limit set to 24 hours a week for **Indian students from September**

Additionally, the government has introduced an income cap of Rs 8 lakh per family and set annual funding limits at Rs 30 lakh for master's degrees and Rs 40 lakh for PhD programs.

Professor Karen McCloskey, academic lead for the Race Equality Charter at Queen's University, emphasized the university's commitment to racial equality, aligning with the Advance HE REC, Queen's Strategy 2030, and the UN Sustainable Development Goals. This

commitment aims to enhance the comfort and sense of belonging for students from diverse ethnic backgrounds.




