SC Clears Path for New UGC Rules to Tackle Caste **Discrimination in Higher Education** -VidyarthiMitra News Desk

The Supreme Court of India has granted the Castes (SC), Scheduled Tribes (ST), and University Grants Commission (UGC) the Economically Weaker Sections (EWS). authority to notify its 2025 draft regulations Key features of the draft regulations include: aimed at combating caste-based discrimination, ragging, and harassment in higher education institutions. This decision comes in response to a public interest litigation filed by the mothers of Rohith Vemula and Payal Tadvi, both of whom died by suicide following alleged caste-based harassment.

While the petitioners, represented by senior advocate Indira Jaising, expressed concerns that the draft regulations amalgamate various forms of discrimination—such as caste bias, sexual harassment, ragging, and disabilityrelated issues—into a single framework, potentially leading to administrative challenges, the Supreme Court allowed the UGC to proceed with the notification. The Court emphasized that the petitioners retain the right to suggest modifications once the National Task Force, established to address these concerns, submits its recommendations. Mumbai to Get 28 Maharashtra Board Exam Results to -VidyarthiMitra News Desk **Be Declared Early This Year New Schools**

In a significant development for students across Maharashtra, the Maharashtra State Board of Secondary and Higher Secondary Education (MSBSHSE) is set to announce the Class 10 (SSC) and Class 12 (HSC) examination results earlier than in previous years. According to MSBSHSE Chairman Sharad Gosavi, the results for both classes are expected to be declared by May 15, 2025, marking a notable advancement from the typical release schedule.

This expedited timeline follows the successful completion of the HSC exams from February 11 to March 18, 2025, and the SSC exams from February 21 to March 17, 2025 . Over 15 lakh students appeared for the HSC exams, while more than 16 lakh students took the SSC exams, reflecting the extensive reach of the state's education

Once released, students can access their results through the official MSBSHSE website at mahresult.nic.in by entering their roll number and mother's first name. Additionally, results will be available via SMS, the Digilocker platform, and the official mobile app, ensuring multiple avenues for students to obtain their scores.

This early declaration aims to provide students with ample time to plan their academic futures, whether that involves selecting streams for higher secondary education or preparing for college admissions and entrance examinations. Bombay High Court Declines to Hear PIL on 75% **Attendance Rule for Law Colleges** -VidyarthiMitra News Desk

The Bombay High Court recently dismissed a **Petitioner's Response and Court's Direction** Public Interest Litigation (PIL) that sought strict enforcement of the 75% attendance requirement in law colleges affiliated with Mumbai University. The court cited a lack of specific evidence and details in the petition.

Background of the Petition

The PIL was filed by Sharmila Ghuge, an assistant professor at SVKM's Jitendra Chauhan College of Law. She highlighted Ordinance 6086 of Mumbai University, which mandates a minimum of 75% attendance in lectures, practical sessions, and tutorials for students to be eligible for examinations. Ghuge alleged that many law colleges under Mumbai University were not adhering to this rule, allowing students with attendance as low as 0% to 30% to appear for exams. She attributed this to students engaging in internships or employment during their studies and claimed that colleges were not taking action against such violations.

Court's Observations and Decision

A division bench comprising Chief Justice Alok Aradhe and Justice M.S. Karnik observed that the petition lacked concrete details, such as the names of specific colleges or students who were permitted to take exams despite insufficient attendance. The court noted that Ghuge, being a faculty member, did not provide data even from her own institution. The bench emphasized that without material particulars, the court could not entertain the petition.

Ghuge informed the court that her attempts to gather information through Right to Information (RTI) applications were unsuccessful, as authorities refused to provide the requested details. The court advised her to pursue appeals under the RTI Act to obtain the necessary information. It granted her the liberty to file a fresh petition once she had gathered relevant

Implications and Broader Context

evidence to support her allegations.

This case brings to light ongoing concerns about attendance policies in legal education, especially regarding students balancing academic requirements with internships or employment. While the court did not dismiss the importance of enforcing attendance norms, it underscored the necessity of substantiating claims with specific evidence when seeking judicial intervention.

The dismissal of this PIL serves as a reminder of the importance of detailed documentation in legal proceedings, particularly when addressing systemic issues within educational institutions.



Uniformity Out, Individuality In: Maharashtra Schools Regain Choice in Dress Code

In a significant policy reversal, the Maharashtra government has officially scrapped its "One State, One Uniform" initiative, restoring autonomy to schools in determining their own uniform designs and colors. This change, effective from the 2025-26 academic year, empowers School Management Committees (SMCs) to oversee not only the procurement and distribution of uniforms but also their design and fabric selection.

Background: Centralized Uniform Policy and Its Challenges

Introduced in 2023 under the Sarva Shiksha Abhiyan, the centralized uniform policy aimed to standardize student attire across all government schools in Maharashtra. However, its implementation numerous challenges, including delays in distribution, ill-fitting uniforms, and complaints about poor-quality fabric. These issues led to widespread criticism from parents, educators, and opposition parties.

Shift Back to Decentralization

Responding to the backlash, the state government issued a Government Resolution (GR) in December 2024, transferring the responsibility of uniform procurement and distribution back to SMCs. This move was aimed at addressing the inefficiencies of the centralized system and restoring local control over uniform-related decisions.

Embracing Local Identity and Choice

Under the revised policy, SMCs are now authorized to decide on the color and design of school uniforms. This change allows schools to reflect local cultures and preferences in their attire, moving away from a one-size-fits-all approach.

Additionally, SMCs are instructed to ensure that the fabric used is of good quality and skin-friendly, avoiding materials like complete polyester.

Reactions from the Education **Community**

The decision to decentralize uniform policies has been met with approval from various stakeholders. Educators and parents have expressed relief at regaining control over uniform decisions, emphasizing the importance of local autonomy in educational matters. The move is seen as a step towards respecting the diversity and individuality of students across the state.

Mumbai University Opens UG and PG Pre-Registrations for 2025-26 Academic Year

The University of Mumbai has officially opened the pre-registration process for undergraduate and postgraduate admissions for the academic year 2025-26, giving thousands of students a head start in their journey towards higher education. This year, there's a crucial update: students are now required to have an Academic Bank of Credit (ABC) ID before registering. The ABC ID, introduced under the National Education Policy (NEP) 2020, is designed to help students store their academic records digitally and move flexibly between institutions if needed. Without this ID, candidates will not be able to proceed with their applications.

According to university officials, the admission process will unfold in two phases.

- The first phase will cater to students who are applying before their final examination results are declared, based on their preliminary marks or internal assessments.
- The second phase will accommodate students who register after their final qualifying results are announced, ensuring that no applicant misses out due to delayed results from different education boards.

Students must complete the pre-registration online through Mumbai University's official portal. During registration, they are required to provide accurate personal, academic, and contact information, along with uploading essential documents like previous marksheets, photographs, ID proofs, and the ABC ID confirmation.

University authorities have emphasized the importance of entering correct details. "Mistakes in the application form can lead to disqualification at a later stage, even if the student is otherwise eligible," a senior admission official said. To help students, detailed user manuals, video tutorials, and a dedicated helpline have been set up.




