ICAI Postpones CA Exams Scheduled for May 9–14 Amid **Rising Border Tensions** -VidyarthiMitra News Desk

In light of the escalating tensions along the India-Pakistan border, the Institute of Chartered Accountants of India (ICAI) has announced the postponement of the CA Final and Intermediate examinations that were originally scheduled to be held between May 9 and May 14, 2025. The decision comes as a precautionary measure to ensure the safety and well-being of students and examination staff during this period of heightened uncertainty.

Rescheduled, Not Cancelled

While the exams have been postponed, ICAI has clarified that all examination centres and their allotted timings will remain the same, and the papers will be conducted on new dates, which will be communicated shortly

The institute emphasised that this decision was taken in the best interest of the candidates, many of whom would have to travel long distances or to sensitive regions to appear for their exams. By postponing the papers, ICAI aims to minimise risk while preserving the integrity of the examination

COMEDK 2025 Shift 3 Postponed in 12 Cities; Revised Dates Expected Shortly

The Consortium of Medical, Engineering and Dental Colleges of Karnataka (COMEDK) has announced the postponement of the COMEDK 2025 Undergraduate Entrance Test Shift 3 in 12 selected cities, following governmental instructions under Operation Sindoor. The examination, originally scheduled for May 10, 2025 (Shift 3), was set to host around 3,000 students in these affected regions. However, due to safety concerns and official directives that mandated the closure of educational institutions in the specified cities, COMEDK has decided to delay the exam for these centres. Despite the disruption in a few cities, COMEDK 2025 continued as planned for the rest of the country. The exam was successfully conducted for other students in unaffected regions according to the timings and sessions mentioned in their admit cards. In total, around 1.31 lakh candidates were scheduled to appear for the COMEDK examination on Saturday, May 10, 2025.

This clarification brought relief to students outside the impacted zones, allowing the vast majority to proceed with their exams as expected. COMEDK's commitment to conducting the test in a fair and safe manner was evident in the way it handled the logistical challenge of partial postponement. The cities affected by the postponement include Jamnagar (Gujarat); Srinagar and Jammu (Jammu and Kashmir); Ludhiana, Bathinda, Jalandhar, Mohali, Patiala, and Amritsar (Punjab); and Jodhpur, Bikaner, and

Sriganganagar (Rajasthan). Each of these cities has been assigned specific test city codes, which have been mentioned in official notices. Candidates who were allotted centres in these locations have been urged not to panic or worry. The official statement from COMEDK advised students to stay informed by visiting the official websites www.comedk.org and

www.unigauge.com regularly for further notifications, updates, and revised schedules.

The organization is currently working in alignment with the concerned authorities to finalize the new dates, taking into account the prevailing conditions and logistical feasibility. Students are advised that the new dates will be declared with ample notice, allowing them to reorganize their travel plans and preparation strategies. The authorities are also expected to take all necessary steps to avoid any additional inconvenience for the affected candidates, ensuring smooth conduct of the rescheduled Shift 3 exam.

As of now, the official COMEDK website displays the message "Update will be done shortly" next to the answer key and result timelines.



Mumbai University to introduce civil defence course in academic curriculum

In a notable initiative to enhance emergency preparedness and response capabilities, the Maharashtra government has announced the introduction of a civil defence course across engineering colleges affiliated with the University of Mumbai. This decision follows a surge in attention toward civil emergency systems, especially after the mock drills conducted in the wake of tensions along the Indo-Pakistan border. The government is aiming to integrate civil defence awareness and training into the academic curriculum to ensure that young citizens are better equipped to handle emergencies. A Memorandum of Understanding (MoU) was recently signed between the Directorate of Civil Defence and Mumbai University, confirming the course's implementation, which will carry a weightage of 25 marks and include practical training in rescue and emergency response.

The Director of Civil Defence, Prabhat Kumar, stated that this academic integration would provide students with hands-on experience and prepare them to work in coordination with public service departments like fire brigades, disaster management teams, and hospitals, especially during wartime or disaster scenarios. He emphasized that this initiative would enable youth to contribute to national service while continuing their education. Students enrolled in this course will be trained to act as first responders during natural or man-made emergencies, contributing significantly to public safety and resilience.

This development comes amid efforts to revive the Directorate of Civil Defence, which has long suffered from underresourcing, outdated infrastructure, and a

lack of trained personnel. The Directorate currently operates with just 135 personnel against a sanctioned strength of 420, with many districts—such as Ratnagiri and Sindhudurg—having only one governmentappointed staff member. Logistical issues such as the non-availability of functional sirens, ambulances, and operational vehicles further hamper the efficiency of the department. Civil defence volunteers are also under-compensated, with a current daily allowance of ₹150, prompting the state to consider raising it to ₹500 and provide better support in terms of staffing and training tools.

The urgency of these reforms was highlighted during large-scale mock drills conducted across coastal cities and urban centres like Pune, Nashik, and Chhatrapati Sambhajinagar, involving over 10,000 volunteers from multiple emergency response agencies including the NDRF, Home Guard, and Civil Defence units. The exercises revealed critical gaps in infrastructure and coordination, prompting the government to take corrective action.

The Railway Recruitment Board (RRB) has extended the application deadline for the 2025 Assistant Loco Pilot (ALP) recruitment, offering a significant opportunity for aspiring candidates. Initially set to close on May 11, the application window will now remain open until May 19, 2025, providing additional time for eligible individuals to apply for one of the 9,970 available positions across various railway zones in India.

The official BITS Pilani admission page indicates that the application window for BITSAT-2025 Session 2 will start from May 26, 2025, to June 10, 2025.

This announcement is significant for several reasons:

- Opportunity for a Second Attempt: BITSAT (Birla Institute of Technology and Science Admission Test) is conducted in two sessions each year. This second session provides an opportunity for students who may not have performed to their satisfaction in Session 1, or who could not appear for it. - Application Process: The application for BITSAT-2025 Session 2 will be online through the official BITS Pilani admissions portal www.bitsadmission.com.
- Test Structure and Syllabus: BITSAT typically includes sections on Physics, Chemistry, Mathematics/Biology, English Proficiency, and Logical Reasoning.
