Maharashtra to Begin NEP 2020 Implementation in June 2025: Changes Coming to Early Education

As deadline ends today, over 86% Maharashtra schools complete geo-tagging process

As of April 30, 2025, over 86% of schools in Maharashtra have completed the mandated geo-tagging process, meeting the deadline set by the state government. Out of 1,08,301 schools, 93,548 (approximately 86.38%) have been successfully geo-tagged, leaving 14,753 schools yet to complete the process.

Purpose of Geo-Tagging

The initiative aims to enhance educational planning by integrating Geographic Information System (GIS) data with existing school information. Previously, the Unified District Information System for Education Plus (UDISE+) lacked spatial data such as exact school locations, proximity to roads, and nearby facilities. To address this, the Maharashtra Remote Sensing Application Centre (MRSAC) developed the Maha School GIS mobile application, enabling schools to upload geospatial data and photographs of key infrastructure.

District-Wise Progress

- **Highest Completion:** Sindhudurg district leads with 97.76% of schools geo-tagged.
- **Lowest Completion:** Mumbai (Suburban) district has the lowest completion rate at 73.46%.
- **Highest Number of Schools Tagged:** Pune district has geo-tagged 6,648 schools, the highest in the state.
- **Lowest Number of Schools Tagged:** Hingoli district has geo-tagged 1,024 schools, the lowest in the state.

This funding supports the integration of geospatial data improve policy planning and resource allocation in the education sector.

Implementation Details

The geo-tagging process requires schools to:

1. Capture the school's latitude and longitude coordinates with a timestamp.
2. Upload five photographs depicting the school building, kitchen shed, boys' and girls' washrooms, and drinking water facility.

This data is collected via the Maha School GIS mobile application, developed by MRSAC. The application integrates this information with existing UDISE+ data to create a comprehensive dashboard for policymakers.

Security Concerns

Some educators have raised concerns about the requirement to download the Maha School GIS app through an Android Application Package (APK) file, citing potential security risks. The state education department has yet to address these concerns publicly.

Despite the success of this drive, Education Commissioner Sachindra Pratap Singh was unavailable for comments on future steps and the next phase of implementation. However, the initiative represents a milestone in digitally strengthening education governance, promising better infrastructure and accessibility for students across Maharashtra.

Budget Allocation

The Maharashtra government has allocated ₹1.04 crore for the geo-tagging initiative, covering both schools and Anganwadi centres.

MHT CET new date announced for cancelled April 27 morning session exam

The Maharashtra State Common Entrance Test (MHT CET) Cell has officially announced a re-examination for the PCM (Physics, Chemistry, Mathematics) group candidates who appeared in the morning session on April 27, 2025. This decision follows reports of significant errors in the Mathematics section of the English-medium question paper, affecting approximately 24,744 students.

New Exam Date

- **Re-examination Date:** May 5, 2025
- **Eligible Candidates:** All students who appeared in the April 27 morning session
- **Admit Cards:** Fresh admit cards will be issued; candidates should download them from the official CET Cell website: cetcell.mahacet.org

Reason for Re-examination

The re-examination has been necessitated due to the discovery of 21 major errors in the Mathematics section of the English-medium paper. These errors were primarily due to faulty translations from Marathi to English, leading to mixed-up answers and jumbled options. Notably, the Marathi and Urdu-medium papers did not encounter such issues.

Next Steps for Candidates

1. **Check Eligibility:** Verify if your name appears on the list of candidates eligible for the re-exam, which will be published on the official CET Cell website.

2. **Download Admit Card:** Obtain the new admit card from the official website once available.

3. **Prepare Accordingly:** Utilize the additional time to review and strengthen your understanding of the Mathematics section.

The CET Cell has also assured candidates that adequate technical arrangements will be in place for the re-examination on May 5, 2025, to avoid a repeat of the issues faced earlier. Centers will be thoroughly checked for their technical readiness, and mock runs may be conducted beforehand to ensure smooth conduct of the exam. The authorities are taking the matter seriously to maintain the transparency and fairness of the examination process.

In conclusion, the decision to conduct a re-examination for the MHT CET 2024 morning session held on April 27 due to technical difficulties reflects the authorities' commitment to fairness and transparency in the examination process. By rescheduling the exam for May 5, 2025, and ensuring proper technical arrangements are in place, the CET Cell aims to provide all affected candidates with an equal opportunity to perform to the best of their abilities. As the re-examination date approaches, students are advised to stay updated.

The Budget also raised the income tax exemption threshold to ₹12 lakh per annum under the new tax regime. This increase ensures that families with incomes up to ₹1 lakh per month are not liable to pay income tax, thereby releasing more money for tuition and living expenses.

Implications for Students and Families

Reduced Financial Burden: The elimination of TCS on education loan remittances and the increased exemption threshold lower upfront tax costs, making overseas education more accessible for students from middle-class families.

Enhanced Affordability: With higher remittance limits before TCS applies, families can plan and transfer funds more efficiently, reducing the financial strain associated with studying abroad.

Encouragement for Education Loans: The removal of TCS on education loans from specified financial institutions encourages students to consider loans as a viable option for funding their education, potentially reducing the need for self-funding.

Considerations and Compliance

While these measures provide substantial relief, students and families should remain aware of the following:

- Documentation Requirements:** Ensure that all remittances are well-documented and comply with the Liberalized Remittance Scheme (LRS) guidelines to avoid any future compliance issues.
- Tax Filing Obligations:** Be mindful of any tax filing requirements in both India and the host country to maintain transparency and avoid potential tax liabilities.
- Financial Planning:** Carefully plan the timing and amount of remittances to optimize tax benefits and manage cash flow effectively.

In summary, the Union Budget 2025-26 introduces measures that are likely to make studying abroad more financially feasible for Indian students. By revising TCS rates on foreign remittances, the government aims to reduce the financial burden and enhance accessibility to overseas education.





Supreme Court stays Delhi High Court direction to revise CLAT-UG 2025 merit list

On April 30, 2025, the Supreme Court issued an interim stay on the Delhi High Court's directive that required the Consortium of National Law Universities to revise the CLAT-UG 2025 marksheets and republish the final list of selected candidates within four weeks.

Delhi High Court's April 23 Order:

- The Delhi High Court identified errors in question paper Sets B, C, and D of the CLAT-UG 2025 exam.
- It directed that all candidates who attempted these sets should be awarded marks for the flawed questions.
- Candidates who received Set A, which was error-free, were not affected by this directive.

Challenge by a High-Ranking Candidate:

- A candidate who secured All India Rank 22 challenged the High Court's decision in the Supreme Court.
- The candidate argued that awarding additional marks to candidates of Sets B, C, and D, while leaving Set A scores unchanged, created an unfair advantage and violated the principle of equal treatment.

Supreme Court's Response:

- A bench comprising Justices B R Gavai and A G Masih issued a notice on the Special Leave Petition filed against the High Court's order.
- The Court's interim stay halts the implementation of the High Court's directive until further proceedings.

Implications for CLAT-UG 2025 Candidates:

The Supreme Court's stay introduces uncertainty for CLAT-UG 2025 candidates, as the final merit list and subsequent admissions processes are now on hold pending the Court's final decision.

This situation highlights the critical need for fairness and accuracy in competitive examinations, as well as the complexities that can arise when addressing errors in standardized testing.



Old pension scheme extended for select school education and sports department cadres

The Maharashtra government has expanded the scope of the Old Pension Scheme (OPS) to include specific cadres within the School Education and Sports Department. This decision benefits principals and lecturers appointed under the Maharashtra Education Service (MES) Group-A and Group-B (Education Administration Branch) who joined on or after November 1, 2005, based on advertisements issued before that date.

1. Expansion of the Old Pension Scheme:

The Maharashtra government has expanded the old pension scheme for certain cadres under the School Education & Sports Department, following a government resolution (GR) from February last year.

2. Eligibility Criteria:

- The scheme now includes principals and lecturers appointed under the Maharashtra Education Service (MES) Group-A and Group-B (Education Administration Branch).
- Eligible employees must have been appointed on or after November 1, 2005, based on advertisements issued before that date.
- The eligibility includes the Maharashtra Civil Services (Pension) Rules, 1982, Maharashtra Civil Services (Commutation of Pension) Rules, 1984, and the Maharashtra General Provident Fund Rules, 1998.

3. Dissatisfaction Among Educators:

- Some educators, particularly from private aided junior colleges, expressed dissatisfaction, as the decision only applies to professors in the DIET department.
- Ashok Gavhankar, general secretary of the Vidarbha Junior College Teachers Association, stated that similar teachers in private colleges were not included, despite the association submitting a memorandum to the government.

4. One-time Option for Eligible Officers:

Officers appointed through the Maharashtra Public Service Commission (MPSC) recommendations, based on advertisements dated February 20, 2003, and April 8, 2004, have been granted a one-time option to opt for the old pension scheme.

5. General Provident Fund (GPF) Accounts:

- New GPF accounts will be opened for the eligible officers as part of the transition to the old pension scheme.
- Their existing National Pension System (NPS) accounts will be closed, and the accumulated contributions along with applicable interest.

IIT Kanpur sets up AI School with Wadhvani Foundation

Despite drop in global position, IIM-Bangalore tops Indian institutions in QS Executive MBA Rankings 2025

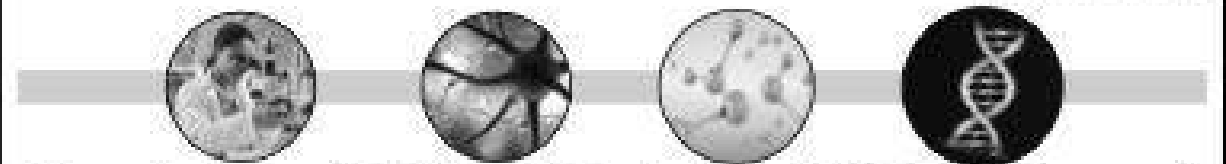
