## CBSE Board Result 2025: Are Grace Marks Given in **CBSE Class 10 and 12 Exams**

The Central Board of Secondary Education (CBSE) is all set to announce the muchawaited Class 10 and Class 12 board exam results for the academic year 2024-25. With over 44 lakh students having appeared for these crucial examinations between February 15 and March 18, anticipation is at its peak. Students, parents, and schools across the country are eagerly awaiting the official declaration of results, which is expected to take place soon. Although an exact date has not yet been confirmed by the CBSE, expectations are high that the results will be released around the same time as last year, which was May 13. In the meantime, the board has also had to issue a clarification dismissing a fake notice regarding result dates that had circulated on social media, reminding everyone to trust only the official CBSE communication channels.

One of the most discussed aspects of the CBSE evaluation system, especially as results draw near, is the provision of grace marks. Yes, CBSE does have a policy in place to grant grace marks in specific cases. These are awarded at the discretion of the board to students who narrowly miss the passing criteria by just a mark or two. The purpose of grace marks is not to give students an unfair advantage, but to assist those who may have shown consistent performance but fallen short of passing by a very small margin. For many students, this can mean the difference between passing and failing, and CBSE uses this provision judiciously to support fairness and academic encouragement. The passing criteria differ slightly for Class 10 and Class 12 students. For Class 10, a student must obtain at least 33% marks in each subject, combining both theory and internal assessment components.

This integrated scoring system allows for some flexibility, especially when students perform better in internal evaluations than in written exams. Therefore, if a student misses the combined threshold by just a mark or two, they may be granted grace marks to pass the subject. This holistic approach to assessment aligns with CBSE's focus on continuous and comprehensive evaluation.

However, the rules are a bit more stringent for Class 12 candidates. In their case, students are required to achieve a minimum of 33% marks separately in both theory and practical/internal assessments for each subject. This separation ensures a balanced evaluation of both written knowledge and practical application. While this stricter policy maintains academic standards, CBSE does sometimes provide grace marks in individual components if the student falls short by only a mark or two. Still, these decisions are made cautiously and only when the student's overall performance justifies it.

The use of grace marks is complemented by CBSE's application of step-marking in mathematics and certain other analytical subjects. Step-marking allows students to earn partial credit for correctly writing the formula, showing correct working methods, or attempting the correct steps—even if the final answer is incorrect. This ensures that students are rewarded for understanding concepts and approaching problems systematically, rather than being penalized entirely for minor arithmetic or calculation errors. It reinforces the educational philosophy that the process of arriving at an answer is as important as the answer itself.

Experts point to mounting academic housing pressure, challenges, job insecurities, and cultural isolation as major stressors. Many international students report difficulty accessing mental health services, often due to stigma, lack of awareness, or inadequate resources on campuses.

## **Calls for Institutional Action**

Education and immigrant advocacy groups are now urging Canadian universities and the federal government to implement more robust safety and wellness protocols, including:

- · Dedicated mental health counselors for international students
- Orientation programs on personal safety and local laws
- Emergency contact systems for families abroad
- Stronger partnerships between schools and local authorities

## **Indian Government Response**

India's Ministry of External Affairs has expressed concern and urged the Canadian government to enhance protections for international students. Discussions are reportedly underway to establish better bilateral communication channels for student welfare. As investigations continue, the tragic death in Hamilton serves as a stark reminder of the vulnerabilities international students face. Advocates stress the need for action—from governments, collective universities, and local communities—to ensure that students pursuing education abroad are safe, supported.

## Navigating 2025: Key Study Visa Reforms in the US, UK, Canada, and Australia Impacting Indian Students

The tightening of visa policies across major study destinations — the U.S., UK, Canada, and Australia — is significantly altering the landscape for Indian students aspiring to study abroad in 2025. Stricter visa enforcement, increased financial requirements, and limited post-study work opportunities are forcing students to adjust their plans, focus on highdemand fields, and explore alternative study destinations. Early planning, staying informed, and seeking professional guidance will be essential for navigating these challenges successfully.

- 1. United States: Stricter Visa Enforcement and Reduced Approvals: The U.S. has significantly increased its scrutiny of international students, expanding the grounds for visa revocation to include minor infractions, such as appearances in criminal or fingerprint databases. This has led to over 4,700 visa terminations, with F-1 visa approvals for Indian students declining by 38% — from 130,000 in 2023 to just 64,008 in 2024. This steep decline reflects a more stringent visa approval process, making it more difficult for Indian students to pursue education in the U.S.
- **United Kingdom: Restrictions Dependents and Affirmation of Graduate Route:** The UK has introduced restrictions on international students bringing dependents, limiting this option to students enrolled in postgraduate programs. However, the country has kept the Graduate Route visa intact, allowing graduates to stay and work in the UK for up to two years after completing their studies. This policy remains attractive to Indian students, offering valuable post-study work opportunities despite the limitations on dependents. Visa processing is being prioritized for applicants enrolling in highdemand fields.

- 3. Canada: Reduced Study Permits and **Increased Financial Requirements:** Canada has cut study permit allocations by 10%, increasing the competition among applicants for the 2025 academic year. In addition, the Guaranteed Investment Certificate (GIC) requirement has been raised to C\$20,635, posing a significant financial challenge for many Indian families. These changes may deter some prospective students from applying or make the process more difficult for those already planning their studies in Canada.
- 4. Australia: Enrollment Caps and Higher Visa Fees: Australia has imposed a cap of 270,000 new international student enrollments for 2025 in an attempt to manage migration levels and address the pressure on housing and university resources. Alongside this, student visa fees will rise from AUD 1,600 to AUD 2,000. These changes could make Australian education less affordable and accessible for Indian students, potentially leading to fewer applications or more cautious planning.
- 5. Enhanced English Proficiency and Financial Proof Across Destinations: In response to growing concerns about student preparedness, all four major study destinations — the U.S., UK, Canada, and Australia — have tightened their requirements for English language proficiency and financial documentation. Applicants must now present higher language test scores and provide more detailed evidence of financial capacity to cover tuition and living expenses. This shift increases the burden on prospective Indian students, requiring more extensive preparation.

# Gadchiroli's Gondwana University to tie up with Australian varsity for new mining courses -VidyarthiMitra News Desk

### 1. Historic MoU Signing:

- Gondwana University (GU) will sign a Memorandum of Understanding (MoU) with Curtin University of Australia on May 7.
- The collaboration will offer three-year diploma courses in mining starting from the July session.

- The total cost of the project is estimated at Rs 200 crore, with the Maharashtra state government funding half of the cost.
- Lloyds Metal has already committed Rs 25 crore towards the project, showing strong support from the private sector.

- The collaboration aims to create a comprehensive, experience-oriented mining education to develop skilled professionals for the mining industry in India.
- The partnership between GU, Curtin University, and Lloyds Metal will help strengthen industry-academia links and promote skill development in a key sector for India's economic growth.

# State halts approvals to new pharmacy colleges in Maharashtra for next 5 years -VidyarthiMitra News Desk

## 1. Decision to Halt New Colleges:

- The higher education department of Maharashtra has decided to stop granting permissions for new pharmacy colleges for the next five years.
- The decision was made due to a large number of vacant seats in existing pharmacy programs.

## 2. Vacancy Statistics:

- Of the 90,000 seats available in graduate and diploma pharmacy programs in the state, 20,000 seats remained vacant last year.
- Data over the past two years shows:
  - 21 colleges had fewer than 10 admissions.
  - 50 colleges had fewer than 20 admissions.
  - 71 colleges had fewer than 30 admissions.
- Vacancies included 6,977 seats for D Pharmacy and 14,000 seats for B Pharmacy programs.

## 3. Focus on Existing Institutions:

 Improving quality of infrastructure, research, and placements in existing colleges.

## 4. Committee for Future Planning:

- A committee of experts has been formed to draft a pharma education plan for 2025–2031.
- The plan aims to align the number of pharmacy graduates with industry employment needs and actual job opportunities.

## 5. Coordination with National Bodies:

- A delegation led by higher and technical education minister Chandrakant Patil met Union Health Minister to present a plan addressing:
  - Employment needs.
  - Industry requirements for pharmacy graduates.
  - Incentives for pharmacy jobs.

## 6. Issues with the Pharmacy Council of India (PCI):

- PCI, the apex body for granting recognition to pharmacy colleges, approves new institutions without fully considering the state's demandsupply balance.
- There was a temporary surge in pharmacy admissions post-pandemic, but the trend has not sustained.

# Delhi CM meets parents of private school students; assures regulation, transparency in fee fixation -VidyarthiMitra News Desk

## 1. Introduction of the New Bill:

- The Delhi Cabinet has approved the Delhi School Education (Transparency in Fixation and Regulation of Fee) Bill, 2025.
- This bill aims to regulate fees in all 1,677 private schools in Delhi, ensuring transparency in the fee fixation process.

## 2. Engagement with Parents:

- Chief Minister Rekha Gupta and Education Minister Ashish Sood met with parents of private school students to address concerns about arbitrary fee hikes.
- Parents welcomed the bill as a significant step that benefits students and families.

## 3. Mechanism for Fee Regulation:

- The bill requires the formation of committees at the school level, which will include parents, school management, and other stakeholders.
- These committees will ensure that any fee increases are justified and transparent.

## 4. Government's Commitment:

- The Chief Minister assured that the government would prevent any injustice related to school fees.
- Parents facing issues over fee-related harassment were encouraged to directly contact the Chief Minister's or Education Minister's offices.
- 5. Expansion of Government Schools:

- Plans are underway to establish 65 new CM Shri Schools with high-quality facilities.
- This initiative aims to provide parents with better alternatives to private schools.

## **Addressing Past Issues:**

- The Education Minister pointed out that under previous administrations, school fees were raised annually without proper oversight.
- A recent example cited involved prolonged protests by parents in Dwarka since 2020, which only saw resolution under the current government.

This initiative reflects the Delhi government's commitment to promoting transparency, fairness, and accessibility in the education sector.



# CBSE 10th, 12th Results 2025: Board issues clarification on fake notice -VidyarthiMitra News Desk

- CBSE recommended relying only on official communication channels for accurate and trustworthy updates.
