CBSE to Hold Class 10 Board Exams Twice a Year from 2026

In a landmark move under the National Education Policy (NEP) 2020, the Central Board of Secondary Education (CBSE) has session, Class 10 board exams will be conducted twice a year.

First Exam in February, Second Chance

The first exam will be mandatory for all students and held in mid-February.

The second exam, scheduled for May, will be optional and allow students to improve marks in up to three subjects.

Best Score Will Be Counted

Only the better score from the two attempts will be reflected in the student's final mark and schools to perform in both exams. sheet. The final results will be announced after the second exam in June.

Aim: Less Pressure, More Flexibility

The CBSE says the move is aimed at reducing academic stress, offering greater flexibility, and encouraging students to focus on learning over memorization.

Mixed Reactions from Stakeholders

Maharashtra ends caste quotas in FYJC colleges run by minorities. -VidyarthiMitra News Desk

In a significant shift in education policy, the Maharashtra Education Department has officially withdrawn the caste-based reservation policy—covering Scheduled Castes (SC), Scheduled Tribes (ST), and Other Backward Classes (OBC)—for admissions to junior colleges operated by minority institutions. This major change was implemented following directives from the Bombay High Court, which urged the government to revise the existing reservation framework in line with constitutional provisions safeguarding minority rights. Acting on this directive, the government issued the new policy on June 23.

Under the updated admission guidelines, minority-run institutions that offer First Year Junior College (FYJC) or Class 11 education will now base admissions solely on students' academic merit. As a result, students from reserved categories will no longer be granted admissions under a quota system in these colleges. This includes a number of highly sought-after and reputed junior colleges in major urban centers such as Mumbai and Pune, which traditionally saw high competition for reserved seats.

The impact of this policy change is expected to be far-reaching, potentially affecting thousands of students who had been depending on reservation benefits to secure admission to prestigious colleges. Supporters of the decision argue that it upholds the autonomy of minority institutions—which are

constitutionally allowed to set their own admission rules—and ensures that students are selected based on academic performance and merit, promoting a level playing field.

However, critics and social justice advocates have expressed strong concerns. They fear that decision could disproportionately disadvantage students from socially and economically weaker backgrounds, for whom reservation served as a critical support mechanism. Several student unions, education activists, and community leaders have already begun raising their voices, urging the government to introduce alternative support systems, such as need-based scholarships, financial aid programs, and preparatory schemes, to ensure that underprivileged students are not left behind.

As the academic year progresses, the real implications of this policy shift will become more evident, and the debate over equity versus institutional autonomy is likely to continue in public discourse and legal forums.

These admissions will once again be based on Class XII board exam cutoff marks, not the Common University Entrance Test (CUET), making it more accessible for women from backgrounds. NCWEB provides a unique opportunity for women who are unable to attend regular college due to personal, financial, or professional commitments. Classes are held only on weekends or during academic breaks, offering the flexibility to balance education with other responsibilities.

NCWEB is a long-standing initiative of Delhi University aimed at empowering women through accessible education. Last year, over 13,000 students were admitted under this scheme, although several seats remained vacant due to the limited number of eligible applicants. This year, the university expects stronger participation. The admissions will begin once the ongoing Common Seat Allocation System (CSAS) for regular undergraduate courses moves into its second phase, which includes the mid-entry window. The application portal for NCWEB courses is expected to open later this week.

These programmes are offered through about 26 colleges affiliated with Delhi University, including well-known institutions like Hansraj College, Kirori Mal College, and Janki Devi Memorial College. During the application process, students will be able to choose from more than 200 college-course combinations. Delays in CAP Process Push First-Year Engineering Admissions Further, Students Left Waiting -VidyarthiMitra News Desk

Engineering (BE) and Bachelor of Technology (BTech) courses under the Centralised Admission Process (CAP) are yet to begin in Maharashtra, even though the new academic year has already commenced. The delay is primarily due to new policy changes proposed by the Directorate of Technical Education (DTE), which are yet to be officially approved.

Among the key changes proposed is a new 'freeze' option in the first CAP round, where students allotted one of their top three college preferences would have to freeze their seat early. Additionally, a fourth institutional-level round is expected to be introduced, allowing colleges to fill vacant seats on merit basis, with students applying online. However, the formal government resolution (GR) required to implement these changes is still awaited.

The uncertainty surrounding the admission process has left thousands of students and parents anxious. Although the HSC and CBSE Class XII results were declared over two months ago, and the MH-CET results for various courses have already been announced, the admission notifications for professional degree programs such as MBA, BPharm, BBA, and BCA are still pending. Officials have confirmed that admissions for polytechnic diplomas have started, while the other courses under CAP remain on hold.

There are more than 42 engineering colleges in the Nagpur region alone, with a total intake capacity of over 18,000 seats. Yet, nearly 40% or more seats remain vacant each year. Experts

First-year admissions to Bachelor of believe that the delayed CAP schedule is contributing to low admissions, as students often opt for private institutions or universities in other states that start the process on time.

> Many educationists and college administrators have voiced their frustration over the repeated delays. Lalit Khullar, Director of Tirpude Institute of Education and Management, criticised the timing of the changes, stating that such planning should have been completed months ago. He claimed that the delay benefits private colleges not under CAP, who get time to fill their seats before the official process begins. His institute, being autonomous, has already rescheduled its academic year to start from August–September to avoid further academic loss.

> A principal of an engineering college added that this year's delay is worse than before. In previous years, time was consumed due to reservation-related decisions like the Maratha quota, EWS, and girls' reservation. But this time, there is no official communication from the government, and college authorities are only receiving updates through media reports.

> Until the GR is issued and the new CAP rules are formally implemented, students will remain uncertain about their admission timelines. If the current situation persists, the engineering admission process may extend into August or even September, further impacting the academic calendar and enrollment ratios in affiliated colleges.

> This delay may also affect students' preparation and transition into their first year of studies.

Maharashtra FYJC Admission 2025: CAP Round 1 **Allotment List Released on June 26** -VidyarthiMitra News Desk

The School Education and Sports Department, system. Maharashtra, has officially released the Centralized Admission Process (CAP) Round 1 allotment list for First-Year Junior College (FYJC) admissions for the academic year 2025–26. The list was published on June 26, and students were advised to check their allotment status by logging into the official portal, mahafyjcadmissions.in. As per the department's prior communication, the allotment list was expected to go live between 5 PM and 8 PM, although slight delays were possible due to system load or technical

This round of allotment determines which junior college each student has been assigned based on their Class 10 marks, category, and college preference choices submitted during the registration process. Students who have been allotted a seat in this round will now need to complete their admission process at the respective colleges between June 27 and July 3, 2025, by submitting the required documents and paying admission fees. Failure to confirm the seat within this window may lead to the seat being forfeited.

The publication of the CAP Round 1 allotment list is a significant stage in the overall FYJC admission schedule. The process began with the release of the provisional general merit list, followed by a grievance redressal window from June 7 to June 9, where students could raise objections or request corrections if there were any discrepancies in their merit ranking or personal details. These grievances were reviewed and addressed by the respective Deputy Directors of Education, ensuring transparency and fairness in the admission

After resolving all issues, the final general merit list was released on June 11, 2025, providing students with a clear understanding of their ranks. The zero-round admissions took place from June 12 to June 14, reserved for special quotas like minority, in-house, management, and other institutional categories, helping fill seats before open

Following this, the CAP Round 1 merit list was finalized on June 17, and the actual allotment list was released yesterday. Students have now entered the critical phase of confirming their college admissions.

Once this round is complete, the department will publish the vacancy list for Regular Round 2 on July 7, 2025. Students who weren't allotted a seat or are seeking upgradation can apply through the same online system.

The FYJC admission process spans over 9,281 junior colleges in Maharashtra, with over 20 lakh seats across Arts, Commerce, Science, and vocational streams. The online CAP system ensures a transparent, merit-based admission process accessible to students statewide.

Maharashtra Announces Second MAH CET 2025 for BBA, BCA, BMS, BBM Courses -VidyarthiMitra News Desk

In a student-centric move, the Government of Maharashtra has announced an additional round of the MAH CET 2025 for undergraduate programs including BBA, BCA, BMS, and BBM. This decision aims to accommodate thousands of students who were unable to appear for the first round of the exam conducted in April 2025.

The State Common Entrance Test Cell (CET Cell) will now conduct a special CET session to ensure that such students get a fair and equal opportunity for admission in the academic year 2025–26.

Why a Second MAH CET?

In the first MAH CET 2025, around 72,259 candidates registered, but only 61,666 appeared, leaving numerous seats vacant across colleges in Maharashtra. To address this issue, the Higher and Technical Education Department has taken a corrective step to prevent wastage of seats government-aided and private institutions.

"This is about ensuring access and fairness. No eligible student should lose a year due to a missed exam date," a senior CET Cell official said.

Registration and Eligibility

The registration window for the additional MAH CET, which originally opened on June 12, 2025, has now been extended to July 4, 2025 to allow more students to apply.

Exam Schedule and Format

While the exact dates of the exam are expected to be announced shortly, CET Cell officials have confirmed that the computer-based test will be conducted between July 18 and July 25, 2025. The final date and center information will be made available on the official portal.

Admission Impact and Academic Calendar

The second CET round is expected to streamline the undergraduate admissions process, especially for colleges that reported less than 40 percent occupancy after the first phase. Many institutions were forced to consider spot admissions or extended deadlines, which disrupted academic timelines.

"This second CET is essential for keeping the admission cycle on track and minimizing the need for ad hoc measures," said the principal of a leading management college in Mumbai.

However, academic experts have noted that this may result in slight delays in the commencement of regular classes, with new sessions likely to begin in mid or late August 2025 for students joining through this second round.

The government urges all eligible candidates to complete their registration on time and monitor the official website for further updates regarding the exam schedule and counseling process.



NEET-PG 2025 Rescheduled: New Exam Date Set for -VidyarthiMitra News Desk August 3

In a much-anticipated move, the National Board of Examinations in Medical Sciences (NBEMS) has officially rescheduled the NEET-PG 2025 examination. The new date for the postgraduate medical entrance exam is now August 3, 2025. This decision comes in the wake of a Supreme Court directive aimed at bringing more transparency and uniformity to the examination process.

Originally slated for mid-June, the exam had been postponed following concerns from students, educators, and legal authorities over fairness in multi-shift exam models.

Why Was the Exam Postponed?

The Supreme Court recently raised concerns Why It Matters about the integrity of multi-shift exams, especially in national-level competitive assessments like NEET-PG. Multiple shifts with different question papers had led to perceptions of unfairness and inconsistencies in scoring.

To address this, the NBEMS, in consultation with the Ministry of Health and Family Welfare, has now committed to holding the exam in a single shift to ensure equal opportunity and fairness for all candidates.

Germany's Brain Drain Dilemma: Why Highly Educated **Migrants Are Thinking of Leaving**

Germany has become a hub for educated migrants, with a record 32.1% of non-EU migrants and 30.1% of EU-born migrants in Germany holding university degrees in 2024. Foreign-born workers now make up nearly 16% of the workforce, playing vital roles in sectors like healthcare, IT, and logistics. The number of qualified migrants has steadily risen over the past reflecting their growing decade, importance to the economy. Experts say this highly educated workforce has the potential to boost innovation and address critical labor shortages.

Despite this, many are rethinking their future in the country. A major survey shows that 26% of migrants about 2.6 million people have considered leaving, while 3% already plan to go. Many intend to return to their home countries or move to more welcoming destinations like Switzerland, the US, or Spain. This growing trend of outmigration is raising alarms among policymakers businesses alike.

Discrimination, limited opportunities, and a shifting political climate are driving this trend. Highly skilled professionals in IT, finance, and healthcare are the most likely to leave. Two-thirds of migrants report experiencing discrimination in various areas of daily life from housing to public spaces. A third say they feel only slightly or not at all welcome in Germany, despite their contributions.



Many cite rising anti-immigrant sentiment, tighter immigration policies, and stalled reforms on citizenship and qualifications. The far-right AfD's growing influence and stricter government measures have worsened the sense of exclusion. The rollback of plans to ease citizenship rules has further dampened hopes for long-term integration. These developments signal a broader shift that could threaten Germany's ability to retain essential talent.

Experts warn Germany must urgently become more inclusive and reduce bureaucratic barriers or risk losing the talent needed to address its aging population and worker shortages. The country needs around 400,000 new long-term migrants annually just to sustain its labor market.

Researchers recommend simplifying recognition of foreign qualifications and offering incentives for retention. They also stress the need for a cultural shift toward broader acceptance of diversity.

Proposals like making medical graduates stay five years in Germany are stirring debate and may backfire by deterring international students. Critics argue such measures undermine freedom of movement and may violate principles of fairness. While some support the idea to address rural healthcare shortages, others warn it could create further discontent among young professionals. The balance between public needs and migrant rights remains a complex policy challenge.

Attracting talent is no longer enough Germany must now focus on retaining it. The future of its workforce and economic resilience depends on how well it treats those already contributing. Without urgent reforms and a shift in public attitudes, Germany could face a serious talent drain in the years to come.

The UK is set to witness a historic outflow of 16,500 millionaires in 2025, according to the Henley Private Wealth Migration Report the highest in its history. These individuals, holding an estimated £66 billion in investable assets, are leaving amid sweeping tax changes.

Tax Shake-up Triggers Migration

The primary driver is the April 2025 overhaul of the UK's "non-dom" tax regime. The new rules impose full UK tax on global income and gains for wealthy foreigners after four years of residency, and expose their global assets to a 40% inheritance tax. "This sharp outflow of wealth is not happening in isolation," said Dr. Juerg Steffen, CEO of Henley & Partners, noting it builds on 2024's record departure of 10,800 millionaires.

Millionaires Looking for New Havens

The UK now ranks ahead of China and Russia in projected millionaire losses for 2025. Many are relocating to countries like the UAE, U.S., Switzerland, and Italy, with the UAE expecting to attract 9,800 millionaires this year. Meanwhile, British applications for second citizenships or residencies rose 183% in early 2025.

Malaysia to Introduce 6% Tax on Private Education for **International Students Starting July 2025** -VidyarthiMitra News Desk

Starting July 1, 2025, Malaysia will impose a 6% service tax on private education services for international students, covering all levels from preschools to universities and language centres. Malaysian students will remain exempt. The tax applies to institutions earning over RM60,000 annually, and all higher education providers for foreign students must register, regardless of income.

Government Justifies as Fiscal Reform

The Ministry of Finance defends the tax as part of a broader Sales and Service Tax (SST) reform, aimed at improving public finances without burdening domestic students. "It ensures domestic students are not impacted, while still supporting the long-term goals of the education sector," the Ministry said.

Impact on Malaysia's Global Education

Malaysia has targeted 250,000 international students by the end of 2025. However, experts warn the tax could discourage enrolment, particularly in UK transnational education (TNE) programs, which draw price-sensitive students seeking affordable UK degrees via Malaysian institutions.

British Council Urges Caution

The British Council expressed concern and advised UK institutions working with Malaysian partners to seek professional tax advice. "We recommend institutions consult local tax experts and stay informed," it said, offering support through its regional teams.

Private Sector Seeks Clarification

Many private education providers are now urgently seeking clearer guidelines on the tax's scope and compliance requirements. Institutions worry about the administrative burden and the potential need to raise tuition fees to offset the tax.

Potential Impact on Developing Nations

The tax could particularly affect students from developing countries across Asia and Africa, who often choose Malaysia for its affordability. If costs rise, many may opt for alternative destinations, weakening Malaysia's appeal as a regional education

Indian Students Surrender Social Media Privacy in Bid for U.S. Visas

Indian students applying for U.S. F-1, J-1, or M-1 visas must now make their social media profiles public, as announced by the U.S. Embassy in New Delhi. Platforms like Instagram, X, LinkedIn, and TikTok will be reviewed by consular officers during the visa process a first-of-its-kind policy that has sparked privacy concerns and anxiety among applicants.

While the requirement adds pressure, most students are complying. "I'm going through every tweet I've ever posted,' said a UC Berkeley-bound student. IDP's Regional Director Piyush Kumar noted over 95% of students are adjusting, though a small percentage are now eyeing other destinations like the UK, Canada, and Australia.

Education consultants have raised red flags. "This isn't about academics anymore. The U.S. is reviewing you as a person," said Adarsh Khandelwal of Collegify. Legal experts link the move to rising visa scrutiny under political pressure, with 41% of F-1 visa applications denied in 2023-24. "It's political theater," said U.S. attorney Deepak Ahluwalia.

Many students are now cleaning up their digital presence deleting posts or even deactivating accounts. Rajneesh Pathak of Global North Residency said, "No other country demands this level of visibility."

The move is also increasing the burden on education counselors and legal advisors, who are now guiding students through digital audits alongside academic prep. Some institutions are hosting workshops to help students manage their online profiles responsibly.

Despite the stricter process, U.S. universities remain a top priority for Indian aspirants. The prestige, research opportunities, and global exposure continue to outweigh growing concerns over surveillance and rejections — at least for now.

As the U.S. tightens its visa screening with new digital transparency rules, Indian students face yet another obstacle in their pursuit of American education. High Court Mandates Comprehensive School Safety Reforms in Maharashtra -VidyarthiMitra News Desk

The Bombay High Court has issued a stringent directive to Maharashtra's Education Department, mandating immediate implementation of a Government Resolution (GR) outlining robust safety protocols across all schools in the state.

A division bench led by Justices Revati Mohite Dere and Neela Gokhale was overseeing a suo-motu PIL initiated in the aftermath of the August 2024 sexual assault of two kindergarten girls in Badlapur. The April 2024 GR, formulated on recommendations from a high-level committee chaired by retired judges, specifies multiple safety measures that must now be enforced without delay.

Key Safety Measures (More Concise):

- Inspections: Officers to ensure schools follow safety rules.
- CCTV: Mandatory in key areas; 1-month footage storage; only ~50% schools compliant.
- Staff Checks: Police clearance required; dismiss if criminal record found.
- Transport: Buses need CCTV, GPS, female The Bombay High Court's directive marks a attendants; weekly drug tests and ID checks for all transport staff.
- touch, cyber safety, bullying, and emergencies.
- Facilities: Separate toilets for boys and girls with attendants; ensure hygiene.

- Complaints: Set up complaint boxes; display 1098 helpline.
- Parent Updates: Send printed GR copies to parents/PTAs.

Rolling Timeline Enforced

Initially, schools must submit safety compliance reports every four months. After full implementation, reporting will transition to a biannual schedule. The Court expects visible progress ahead of the upcoming academic year, and has expressed impatience over delaysquestioning if officials are "waiting for another incident to happen"

Accountability and Next Steps

- The Education Department has been ordered to prominently publish the GR on its website and ensure compliance through empowered district officers.
- The Court is closely monitoring implementation, with public hearings scheduled to assess tangible progress.

I wanted students to find joy in learning," Tamboli shared. His students now confidently say phrases like, "Ich liebe Deutsch" (I love German).

Japanese for Primary Students in Aurangabad

In Vadona, Aurangabad, teacher Sunita Lahane Dhoke conducts weekly Japanese sessions for primary school students. Her initiative emerged after she noticed students showing curiosity international culture during online classes in the pandemic. With simple Hiragana scripts and conversational training, even first graders now introduce themselves in Japanese.

A Volunteer's Touch in Beed

In Beed district, local volunteer Kedar Jadhav, who lived in Germany for several years, visits village schools to teach basic German to children. His sessions focus on travel vocabulary and everyday conversation. "They may not need it today, but tomorrow it could change their lives," Jadhav said.

Comprehensive Japanese Curriculum in Satara In Vijaynagar, Satara, teacher Balaji Jadhav has taken the foreign language initiative further. With a structured syllabus, he now teaches over 40 students in standards I to IV how to read, write, and speak Japanese. The language is even incorporated into mathematics lessons, creating a truly immersive experience. Parents say their children are more confident and expressive since the program began.

Policy Alignment and Educational Impact

While these programs are not yet part of the official curriculum, they align with the NEP 2020's emphasis on multilingualism and holistic education. Teachers are using online resources, self-training modules, and cultural exposure to craft lessons that were once unimaginable in rural settings.

The impact is significant. Students are showing improved classroom engagement, parents are more invested, and schools previously facing low enrollment are now drawing attention for innovative practices.

Conclusion

These grassroots efforts prove that about transformation in education doesn't always come from large budgets or mandates. Sometimes, it begins with a passionate teacher, a curious student, and the belief that even a village classroom can be a gateway to the



Tragedy in Ahmednagar Sparks Urgent Push for School **Security Overhaul.**

A grave incident at a residential school in Student Well-being Under Scrutiny Jamkhed, Ahmednagar, has brought school safety to the forefront of public concern. During midday recess, an 8th-standard student fatally assaulted a 10th-standard peer, triggering shock and fear across the school community.

Incident Details

The violent clash occurred during the lunch break. Police have launched an investigation into the motive behind the confrontation. The school atmosphere remains tense, with parents and students expressing alarm over inadequate security arrangements.

Community Response and Administrative

Local residents, along with parents, are demanding immediate implementation of enhanced safety protocols in schools. The incident has renewed calls for stricter child protection measures and proactive monitoring of student behavior on premises.

Context: A Wave of Safety Reforms

This tragedy follows a series of safety incidents prompting the Maharashtra government to introduce comprehensive guidelines, including:

- · Mandatory installation of CCTV and strict bus-safety protocols.
- · Daily background and health screening of school drivers.
- Formation of school-level committees (including parents, teachers) to oversee safety compliance

Experts are emphasizing the urgent need for better mental health infrastructure in schools. They argue that counseling support, conflict resolution training, and early behavioral interventions could prevent such violent outbursts. Schools are being urged to not only focus on physical safety, but also on the emotional and psychological health of students.

Need for Stronger Accountability

Parents and activists are now calling for stricter accountability mechanisms for school authorities. Many believe that regular safety audits, transparent incident reporting, and penalties for negligence must become standard practice. There is a growing consensus that student safety must be prioritized at both policy and ground

Looking Ahead

Education authorities are expected to conduct immediate safety audits in residential schools. Parents and community members are calling for zero tolerance toward violence, improved mental health support, and strengthened monitoring systems to prevent recurrences.

Bottom line: The Ahmednagar tragedy has jolted Maharashtra into action. It underscores the need for urgent, tangible improvements in school safety before another life is lost.

Engineering Admissions in Nagpur Delayed Amid CAP Rule Changes.

The first-year engineering admission process Many have already begun classes, attracting in Nagpur has been delayed due to pending approval of revised Centralised Admission Process (CAP) rules. Despite the academic session being underway in other regions, Nagpur colleges are yet to begin admissions for BE/BTech courses.

CAP Reforms Await Government Clearance

The Directorate of Technical Education (DTE) has proposed key changes to the CAP process, including the introduction of a 'freeze' option during the first three rounds of admission and a fourth round to be conducted at the institutional level. However, these changes require formal approval through a Government Resolution (GR), which is still pending.

Over 40 Percent Seats Remain Vacant

The Nagpur region has around 18,936 engineering seats. With over 40 percent of these seats still vacant, the delay is adding to student anxiety and prompting many to consider institutions outside the region. been issued.

Academic Calendar in Limbo

While autonomous institutes like Tirpude College have shifted their academic start to August-September, CAP-affiliated colleges are left waiting. Principals express concern over the lack of communication, warning that the continued delay could result in loss of an academic term for thousands of students.

Private Colleges Gaining Edge

With the delay in CAP admissions, private autonomous colleges are gaining a competitive students who may have otherwise enrolled in CAP-linked institutes. This growing divide could further impact enrolments in government-regulated institutions.

Voices from the Sector

Manoj Daigavhane, Joint Director of DTE (Nagpur region), confirmed that admissions will begin only after the GR is issued. Tirpude Institute's Director, Lalit Khullar, criticized the delay, suggesting it disadvantages CAP-linked colleges in favor of private ones already operating independently.

What Lies Ahead

If the Government Resolution is not issued in the coming days, engineering admissions in the Nagpur region may only begin in late July or August, risking disruption to the 2025-26 academic calendar and further increasing student migration to other regions or autonomous institutes.

Several college administrators report receiving Summary: Engineering admissions in Nagpur inquiries from students seeking clarification, are currently stalled due to pending CAP but official updates from the DTE have not policy changes. With a large number of seats still vacant and timelines slipping, stakeholders are urging immediate government intervention to prevent long-term academic disruption.




