## KDMC Officials Assess Student Learning Levels to Enhance Education Quality in Civic Schools -VidyarthiMitra News Desk

In a focused effort to enhance the quality of education in its municipal schools, the Kalyan Dombivli Municipal Corporation (KDMC) has launched a comprehensive student assessment initiative aimed at evaluating the academic performance and learning levels of students across its civicrun institutions.

This large-scale assessment drive is being carried out by KDMC's education department to gain a clear understanding of the strengths and challenges faced by students in various grades. By conducting subject-wise and skill-based evaluations, officials aim to generate actionable insights that will inform the development of targeted remedial teaching plans and student-specific interventions.

A senior official from the education department explained that KDMC currently operates more than 120 civic schools, serving thousands of students, many of whom belong to financially disadvantaged households. These children often lack access to private tutoring or advanced educational resources, making school support even more critical. The official further emphasized that the goal is not just to test students but to identify learning gaps and provide focused academic support to those who need it most.

Education experts and child development advocates have praised the move, noting that such assessments are vital, particularly in the wake of learning disruptions caused by the COVID-19 pandemic. During extended school closures, many students in municipal schools experienced a decline in foundational learning due to the digital divide and limited access to structured

learning environments. This initiative is seen as a necessary step in bridging that gap and ensuring students can catch up

Teachers in KDMC schools have also expressed strong support for the initiative. Many believe the results will help them plan their lessons more strategically, allowing them to better address the specific needs of individual students or groups. They hope it will also encourage a culture of data-driven teaching within municipal schools.

As the assessments are completed, KDMC plans to roll out remedial classes, bridge courses, and skill-based learning modules tailored to the needs of students identified as requiring additional support. These efforts aim to not only improve academic outcomes but also boost students' confidence and engagement in the learning process.

The initiative highlights KDMC's commitment to equity in education, ensuring that students from all backgrounds have the opportunity to achieve academic success. If implemented effectively, it could serve as a model for other urban municipalities seeking to improve the quality of education in civic-run schools.



### Maharashtra to Retain Schools, Expand Upper Primary in 6,553 Villages

In a major shift aimed at strengthening rural education, the Maharashtra government has officially decided not to shut down schools with low student enrolment, reversing earlier proposals that had recommended closures to optimise administrative and financial resources. This change reflects a broader commitment to inclusive and equitable access to education across the state, particularly in underserved rural areas.

Instead of cutting back, the government is now focusing on expanding educational infrastructure, especially in villages that currently do not have upper primary schools (classes 6 to 8). According to data from the Education Department, nearly 6,553 villages in Maharashtra lack upper primary school facilities, forcing lakhs of children to discontinue their formal education after class 5. Many of these children are unable to travel long distances due to poor connectivity, economic hardships, or familial constraints.

A senior official from the education department emphasized the government's new direction, stating, "We want to ensure that no child is denied their right to education simply because a school is not available nearby. The focus is now on bringing schools closer to children, rather than expecting children to travel far

Education experts and child rights activists have welcomed the move, warning that shutting down lowenrolment schools would have had detrimental effects on learning especially in outcomes, Maharashtra where issues like seasonal migration, poverty, and lack of public transport already impact school attendance. According to them, closing such schools would have further widened the education gap between urban and rural populations.

The state government has now committed to formulating comprehensive implementation plan aimed at upgrading existing primary schools to include upper primary sections. This includes identifying infrastructure needs, deploying qualified teachers, and ensuring adequate learning resources. The plan is expected to be rolled out in a phased manner to effectively address logistical challenges and ensure smooth execution.

The move aligns with NEP 2020 and aims to boost rural enrolment and learning, setting an example for other

#### FYJC Round 1: High Cut-Offs in Science, Commerce; **Arts Sees Low Demand** -VidvarthiMitra News Desk

The first round of admissions for Maharashtra's current reservation framework and seat First Year Junior College (FYJC) has intensified matrix need urgent review and recalibration. the competition among students, particularly Experts are calling for better balancing those seeking seats in the Science and mechanisms to prevent overlaps and Commerce streams. With the Round 1 allotment unintended consequences in the allotment results released on June 30, a clear trend has process. emerged: cut-off percentages have soared, especially in top junior colleges in Mumbai, Pune, Nagpur, and other urban centers, leaving many students on edge.

In prestigious institutions such as Dr. Ambedkar College, the Science stream recorded a staggering cut-off of 93.2%, while Commerce followed closely at 90.6%. This year's numbers continue a trend seen in recent years—where high-scoring students, especially in Science and Commerce, are clustering in select top-tier colleges, leading to tight availability and rising merit thresholds.

In contrast, the Arts stream has seen a drop in demand, with many colleges reporting significantly lower cut-offs and several vacant seats still up for grabs. This growing imbalance between streams reflects evolving student support for students experiencing technical preferences, where professional and STEM- or policy-related difficulties. oriented courses—often associated with Science and Commerce—are prioritized over Arts and In summary, the FYJC Round 1 admission humanities. Educationists fear that such process has highlighted both the intense disparities may further marginalize Arts academic pressure on students and the education and limit the diversity of academic structural inefficiencies within the current pursuits at the junior college level.

#### **Policy Concerns and Reservation Discrepancies**

Another issue that has sparked widespread debate is the discrepancy in cut-off marks among reserved categories. In several cases, students applying under the girls' reserved category were required to score up to 20 marks more than their peers in the general category to get the same seats. This unexpected reversal has raised concerns among parents, students, and education policy experts, who argue that the

#### **Next Steps for Students**

Despite the challenges, students who have been allotted seats in Round 1 must confirm their admissions by July 7 by reporting to the assigned college and completing the formalities. Those who are unsatisfied with their allotment, or who have not been allotted a seat, will have the opportunity to participate in subsequent admission rounds, where some movement in cut-offs is expected.

Authorities have acknowledged the issues and assured students and parents that steps are being taken to improve the admission process in the next rounds. Officials have promised greater transparency, review of algorithmic procedures, and more responsive

system. While top-performing students compete for limited seats in coveted streams, others struggle with unexpected system flaws and inconsistent reservation policies revealing a need for urgent reforms and better planning in future admission cycles.

## NEET-UG 2025 Result Challenge Rejected by Supreme Court: Counselling to Proceed as Scheduled -VidyarthiMitra News Desk

In a significant development for lakhs of NEET aspirants, the Supreme Court of India on July 4, 2025, dismissed a petition that challenged the NEET-UG 2025 results. The plea alleged that a particular question in the NEET-UG 2025 paper was flawed and demanded the re-evaluation of results along with a stay on the ongoing counselling process. However, the apex court declined to interfere, stating that doing so would adversely impact the future of thousands of students who have already received their results and begun the counselling procedures.

A bench comprising Justice P. S. Narasimha and Justice R. Mahadevan heard the matter and firmly rejected the plea. The judges emphasized that the exam was taken by more than 22 lakh candidates, and any intervention at this stage would cause large-scale disruption. They maintained that the petition could not be entertained, especially since a similar plea had already been dismissed just two days earlier. The court made it clear that national-level entrance examinations involving lakhs of students cannot be undone due to individual errors unless there is evidence of systemic failure.

The petitioner had requested the court to invalidate the NEET-UG 2025 result on the basis of an alleged mistake in a single question and demanded a halt to the

admission counselling process. The court,, however, prioritized the stability of the examination system and the ongoing admission schedule. It noted that such interventions would compromise the careers of numerous students and delay the academic calendar nationwide. "We cannot intervene in a matter that would lead to uncertainty and disruption for so many aspirants," the bench observed.

The NEET-UG 2025 exam was conducted on May 4, 2025, and results were declared in June. The National Testing Agency (NTA), which conducts the examination, had already initiated the counselling process by the time the petition was filed. With the court's decision, the result stands valid, and the Medical Counselling Committee (MCC) can continue with the seat allotment process without any hindrance.

This decision provides clarity and relief to lakhs of students and parents who were worried about possible delays or cancellations. The Supreme Court's ruling sends a clear message: while individual grievances are acknowledged, they cannot override the interests of the larger student community. Legal experts and educationists have welcomed the decision, noting that preserving the integrity and timelines of national-level entrance exams is essential for a fair and stable academic process. In conclusion, the Supreme Court's dismissal of the petition reinforces the importance of upholding result timelines and admission procedures in national examinations like NEET.

#### **CUET UG 2025 Results Out: 13.5 Lakh Appear, Five Top** -VidyarthiMitra News Desk **Scorers Emerge**

The National Testing Agency (NTA) announced the much-anticipated CUET UG 2025 results on Friday, marking a significant milestone in the undergraduate admissions process for central and participating universities across India. Candidates who appeared for the examination can now check their scorecards by visiting the official website at cuet.nta.nic.in. The Common University Entrance Test for Undergraduate (CUET UG) was conducted between May 13 and June 4, spread across 19 days and 35

This year, the NTA opted not to release a conventional list of toppers. Instead, in a first-of-its-kind move, it disclosed the application numbers of students who achieved the highest NTA scores in five subjects. According to the official statement, the NTA is in the process of sending individual scores to participating universities, and candidates have been advised to remain in contact with their respective institutions for details on further admission procedures.

The performance data released reveals some remarkable achievements. One candidate secured a 100 percentile score in four out of five chosen subjects, a rare accomplishment. Additionally, 17 students earned a 100 percentile in three of their subjects. The

number of candidates scoring a perfect percentile in two subjects stands at 150, while 2,679 candidates achieved 100 percentile in one subject. These figures highlight the academic excellence and competitive intensity observed in this year's CUET UG.

CUET UG 2025 was conducted in a total of 37 subjects, which included 13 languages, 23 domain-specific subjects, and a General Aptitude Test. Students had the flexibility to choose up to five subjects from this wide array. To accommodate this complexity, the NTA administered an impressive 1,059 total question papers, including 322 unique sets, covering a whopping 57,940 questions. This represents a substantial increase compared to the previous year, where only 99 unique question papers were used. The expanded paper variety reflects the NTA's commitment to increasing inclusivity and subject-specific assessment in national-level entrance testing.

NTA declared CUET UG 2025 results after releasing the final answer key on July 1. Over 13.5 lakh students registered, with 10.7 lakh appearing across 300 cities. This year saw 239 universities participating, down from 283 in 2024. Candidates should now check university sites for counselling and admissions. #### Trump Administration Halts Key US Military Aid to Ukraine **Amid Escalating Russian Attacks** -VidyarthiMitra News Desk

In a dramatic shift in U.S. foreign policy, the Pentagon has quietly paused shipments of vital military aid to Ukraine, including Patriot air defense systems, Hellfire missiles, and precision-guided weapons. The freeze, effective since early June, follows a Pentagon review led by policy chief Elbridge Colby and reflects growing concerns about depleting U.S. military reserves.

Despite the Biden administration's earlier commitment to Kyiv, the Trump administration has prioritized domestic defense a move defended by the White House as putting "America's interests first," according to Deputy Press Secretary Anna Kelly.

The decision comes as Ukraine faces its largest wave of Russian missile and drone attacks since 2022. Over one weekend alone, Russia launched 477 drones and 60 missiles, straining Ukraine's defenses. President Zelenskyy met Trump at last week's NATO summit to request urgent aid, but Trump offered no firm commitments, only saying, "We'll see if we can make some available."

Ukrainian officials warn that without timely reinforcements, their air defense systems could soon be overwhelmed. The lack of clarity from Washington has further deepened anxieties in Kyiv and among NATO allies.

The aid freeze, which has alarmed NATO allies and U.S. lawmakers alike, aligns with Trump's increasingly critical stance toward Ukraine. He recently called Zelenskyy a "dictator" and praised Putin as a "strong leader," sparking concerns of a growing U.S. strategic withdrawal that could embolden Moscow.

Congressional leaders and defense experts warn the pause could severely weaken Ukraine's ability to defend itself. Rep. Marcy Kaptur stressed that systems like Patriot missiles are "saving lives every day," while analysts argue their absence could shift the war's outcome.

With no new Ukraine aid requests from the Trump administration, and existing funds running out, the future of Western support for Ukraine hangs in the balance — raising fears of a widening security vacuum in Europe.

The U.S. decision to freeze critical military aid to Ukraine marks a significant turning point in its foreign policy and raises urgent questions about the West's long-term commitment to Ukraine's defense. As Russian aggression intensifies and frontline needs escalate, the lack of clear support from Washington threatens to undermine Ukraine's ability to protect itself and risks destabilizing the broader European security order.

### Canada Updates PGWP Eligibility List for Non-Degree **Graduates: What Students Need to Know**

In a significant move affecting international students in Canada, the government has revised the list of fields that qualify nondegree graduates for a Post-Graduation Work Permit (PGWP). The update aims to better align education pathways with Canada's longterm labour market needs.

As part of the changes, 119 new fields of study have been added to the PGWP-eligible list, while 178 have been removed. The updated list now includes 920 qualifying fields in total. The newly included areas focus heavily on healthcare and education, reflecting Canada's ongoing efforts to fill critical worker shortages in these sectors. On the other hand, certain programmes in agriculture and transport have been excluded from the revised list.

#### What This Means for Students?

These changes are especially important for international students pursuing certificate and diploma programmes rather than full degree courses. PGWP eligibility plays a crucial role in helping graduates gain Canadian work experience — a key step toward permanent residency for many.

However, there's good news for current students and recent applicants. If you applied for a study permit before June 25, 2025, and your chosen field of study is no longer on the PGWP list, you will still be eligible for a postgraduation work permit.

The updated PGWP list is part of Canada's strategy to match education and immigration policies with real workforce demands. By prioritising fields where there is a persistent shortage of skilled workers, the government hopes to streamline the transition from

international student to permanent resident especially in sectors like nursing, teaching, and mental health support.

Graduates can apply for a PGWP within 180 days of receiving their final marks. To be eligible, they must have completed their programme at a designated learning institution (DLI) and meet other IRCC (Immigration, and Citizenship Refugees Canada) requirements.

For detailed guidance on how to apply, students are advised to visit the official IRCC website or consult their college's international student services.

Secondary Education (RBSE) has announced that yoga, library periods, and extra-curricular Cultural Clubs and Awareness Drives activities are now compulsory for all government and private schools affiliated with the board. The mandate, effective July 1, 2025, aligns with the goals of the National Education Policy (NEP) 2020, which emphasizes overall physical, emotional, and social development alongside academics.

The new academic calendar released by the board specifies a revised timetable that prioritizes both scholastic and co-scholastic Subjects requiring higher concentration, such as Mathematics and Science, will be conducted during the first six periods of the day, while lighter or skill-based subjects will follow in later periods. This structure is designed to align with students' natural attention spans and reduce cognitive overload.

#### Mandatory Library & Yoga Sessions

One of the key inclusions is a weekly library period, which aims to cultivate reading habits and improve language skills. Additionally, yoga sessions will now be conducted regularly to enhance physical fitness, reduce stress, and promote mindfulness among students.

According to RBSE officials, these additions are not optional; schools are expected to incorporate them into their weekly schedules and maintain attendance records. Regular

The Rajasthan Board of Secondary Education (RBSE) has introduced new reforms mandating the creation of at least one student club in each senior secondary school. Suggested clubs include Science, Child Rights, Environment, Road Safety, and Tourism Awareness. Schools must also appoint a "tobacco monitor" in every class and conduct at least one literary or cultural activity per term for students of Classes 9 and 10.

#### **Bal Sabhas and Cleanliness Campaign**

With these developments, all establishment of 19 new government degree colleges under the Pradhan Mantri Jan Vikas Karyakram (PMJVK)—a central initiative aimed at uplifting regions with significant minority populations. This step is part of a broader strategy to bridge regional and social disparities in access to higher education. The announcement closely follows the recent operational readiness of 69 government degree colleges, which were scheduled to begin academic sessions by July 1, 2025, marking the start of the 2025-26 academic year.

The 19 newly sanctioned colleges will be spread across 15 districts, including Meerut, Ghaziabad, Pratapgarh, Unnao, and Sant Kabir Nagar. Two additional colleges are in the construction phase and are expected to be completed by 2026–27. The Ministry of Minority Affairs has approved financial grants to facilitate the development of these institutions, in partnership with various state-level education and infrastructure bodies. The final administrative model for these colleges—whether they will operate fully under government control or through a Public-Private Partnership (PPP)—is currently under evaluation. The state's Higher Education Department is overseeing the entire project to ensure that construction, staffing, and academic activities remain on schedule.

This push for expansion is part of a larger infrastructural overhaul of the state's tertiary education system. Alongside the new colleges, the government has simultaneously inaugurated 71 newly constructed degree

172 government colleges in Uttar Pradesh will now offer comprehensive academic programmes in science, commerce, and arts streams, aligning with the National Education Policy (NEP) 2020 and its emphasis on interdisciplinary education and flexible curriculum models.

To support this academic expansion, the state government has also received inprinciple approval for 1,562 new teaching positions, including 1,065 assistant professors. While the recruitment process for permanent faculty is underway, the government has arranged for temporary deputation of faculty from existing institutions to ensure that academic operations in the new colleges are not hindered. This proactive approach highlights the administration's intent to prioritize uninterrupted and quality instruction during the transition phase.

### SSC CPO (SI) Tier 1 Exam 2025

The Staff Selection Commission (SSC) conducts the Central Police Organization (CPO) examination to recruit Sub-Inspectors (SI) in Delhi Police and Central Armed Police Forces (CAPFs). The Tier 1 examination is the first crucial step for candidates aiming to join these elite forces. With the 2025 cycle underway, aspirants must understand the structure, important dates, and the type of questions they are likely to encounter.

#### **Exam Overview**

SSC CPO Tier 1 is a Computer-Based Test (CBT) that assesses a candidate's abilities across four key subjects: General Intelligence and Reasoning, General Knowledge and General Awareness, Quantitative Aptitude, and English Comprehension. Each section carries equal weight, with 50 questions and 50 marks allotted to each. The total paper consists of 200 questions for 200 marks, and the duration is 2 hours. The official notification for SSC CPO 2025 was released on June 16, 2025. The application process began on the same date and will remain open until July 7, 2025. Candidates must ensure that they submit their forms and fees well within this window. The Tier 1 examination is scheduled to be held from September 1 to 6, 2025, across various centers in India. Admit cards are expected to be available in the last week of August.

#### **Key Points Candidates Must Remember**

First, the exam is open to graduates aged between 20 and 25 years, with age relaxations applicable to reserved categories. Second, preparation must focus on both academics and physical fitness, as qualifying the PET/PST is mandatory. Third, understanding the exam pattern and practicing mock tests is essential to gain an edge in the competition. Lastly, candidates should monitor the official SSC website for updates, especially regarding admit cards and exam centers.


