## MAH B.Pharm, Pharm.D Admissions 2025 Begin ; Register Online by July 14

The Maharashtra CET Cell has opened registrations for B.Pharm and Pharm.D courses from July 7 to July 14, 2025. Eligible students with MHT-CET or NEET scores can apply online at mahacet.org. After registering, candidates must upload their documents and complete verification between July 8 and July 15.

The provisional merit list will be released on July 18, giving students time to raise objections or correct errors by July 21. The final merit list will be declared on July 23, after which the Centralised Admission Process (CAP) seat allotment will begin.

Key eligibility: Class 12 pass with Physics, Chemistry, and Biology or Maths for B.Pharm; Pharm.D also accepts D.Pharm diploma holders. Preference is given to

NEET over CET scores for Pharm.D admissions.

Admissions for B.Pharm and Pharm.D courses in Maharashtra have officially started today. Students eager to pursue pharmacy can register online until July 14. After applying, they need to upload documents for verification, either online or at designated centres.

The CET Cell will announce a provisional merit list on July 18, allowing candidates to resolve any discrepancies before the final list on July 23. The admission process uses the CAP system, ensuring fair seat allotment based on merit and preferences.

Candidates must carefully verify all personal and academic details in the provisional list to avoid future issues. Grievances or corrections can be submitted online through the official portal within the specified timeframe.

The final merit list will be used to initiate the CAP rounds, where candidates can select and confirm their preferred colleges and courses.

## Over 1.5 Lakh Students Compete for Just 1.1 Lakh Polytechnic Seats Across Maharashtra

Thousands of Aspirants Battle for Limited Diploma Admissions in State

The race for polytechnic diploma seats in Maharashtra has intensified this year, with more than 1.5 lakh students applying for only around 1.1 lakh available seats across the state. According to data released by the Directorate of Technical Education (DTE), 1,50,684 students have registered for diploma admissions, indicating a strong preference for technical education among school pass-outs.

In the Nagpur region alone, there are 14,000 applicants competing for just 12,500 seats spread across 51 institutes. Officials said that students are increasingly opting for polytechnic diplomas to secure early employment opportunities or lateral entry into engineering degree programmes later.

We have seen a steady rise in diploma applications as students find them a practical path to job readiness," shared a senior official from the DTE admission cell.

The first merit list for these admissions was released on July 7, while the Centralised Admission Process (CAP) Round 1 will commence from July 13 and continue till August 14. Authorities have urged students to complete document verification and

confirm admissions within deadlines to avoid cancellation of allotted seats.

The diploma courses offered include streams such as civil, mechanical, electrical, computer, and architecture, which are considered to be Maharashtra's growing infrastructure, manufacturing, and IT sectors.

Parents and students are anxiously awaiting the CAP rounds as competition remains stiff, especially in top government polytechnic institutes that offer high placement rates with minimal fees.

1.5 lakh students have applied for 1.1 lakh polytechnic seats in Maharashtra. **Nagpur region:** 14,000 applicants for 12,500 seats in 51 institutes. First merit list released July 7; CAP round 1 from July 13–August 14. High demand is driven by practical job prospects and further engineering opportunities.



## Engineering Tops as Maharashtra CET 2025 Admissions Begin for 16 Courses

The Maharashtra State CET Cell has officially opened admissions for 16 different professional courses, marking a crucial phase for students aiming to enter fields like Engineering, MBA, and B.Ed this academic year.

According to officials, engineering courses have received the maximum number of applications, reaffirming their dominance as the top choice among students in Maharashtra. Following closely are MBA and B.Ed programmes, which continue to attract thousands of aspirants seeking career advancement in management and education sectors.

The admissions are being conducted entirely online, making the process accessible to students across urban and rural regions. The CET Cell has advised applicants to carefully check eligibility criteria, document verification requirements, and key dates to avoid last-minute issues.

Engineering has always been a preferred stream due to vast career opportunities in private and government sectors. We see a consistent rise in its demand every year," said a senior CET official.

Currently, the registration and document verification processes are underway. The authorities have also assured that guidelines and detailed notifications for each course are available on the official CET Cell portal, ensuring transparency and ease for students and parents during the admission process.

Admissions for 16 CET courses opened today.

Engineering has received the highest number of applications, followed by MBA and B.Ed.

The entire process is online, with clear instructions on eligibility, documents, and deadlines.



## Maharashtra Rolls Out Unified FYJC Admissions with Stratospheric Cut-Offs

Maharashtra's education department has launched its first-ever centralized online admissions for First-Year Junior College (FYJC/Class 11) with a unified timetable to streamline the process and ensure transparency.

The first merit list was released on July 1. At Dr. Ambedkar College, Nagpur, Science cut-off was 93.2% and Commerce 90.6%, while Arts saw fewer applications. This trend, favoring Science and Commerce, was evident across urban, rural, and semi-urban areas.

By July 3, over 73,000 students in Vidarbha confirmed seats in Round 1, contributing to a statewide total of 300,000+. Mumbai led with 55,727 admissions, followed by Pune 53,348

and Nashik (39,561).

Students must complete online confirmation, documentation, and fee payment by July 7. Round 2 begins on July 9.

Experts welcome digitization but warn that rising cut-offs are excluding many, especially girls in reserved categories, who reportedly face up to 20-point higher benchmarks. Authorities are urged to address gender and regional disparities and expand seat availability.

They also recommend periodic reviews of the admission process to ensure fairness and equal opportunity for all students.



## Vidarbha Sees 1.32 Lakh FYJC Seats Allotted in CAP Round 1

It was a major update in the Class 10 students who passed to the First Year Junior College (FYJC) in class 10 in Maharashtra, in which 1.32 lakh students in Vidarbha managed to win a college seat and go to first round allotment. Official statistics published on July 1, 2025, show that 1,32,708 seats of the total count of 4,08,490 have been reserved in the various education divisions of the state of Vidarbha. This is a 32.5 percent allotment rate compared to the average level of 30 proposed by the state. Science was the most popular one, getting 40.7 percent of the total admission.

The next was Commerce with 20.9% and only 27.5% in Arts, showing a change in choice of students towards stream-based jobs. In the Vidarbha region, Amravati Division led the list with a mark of 34.4 percent allotment rate, and Nagpur with 30.9. The greater response rate in Amravati has been explained by the superior setup of online outreach campaigns and active involvement in help centers at the school level.

Round 1 admitted students are required to ensure they have confirmed their admissions by July 7. This is done through verification of documents—either physically or online—payment of a fee, as well as locking of the allocated seats. Individuals who cannot give their confirmation of admission will be shifted automatically to the next rounds or may even lose their positions. This has been applauded as a model of digital transparency

and user-friendly execution, whereby online channels make the admissions process smooth even in high-pressure situations. Since the attention is currently on CAP Round 2, students are advised to visit merit lists as well as seat vacancy reports to stand a better chance of acquiring preferred colleges.

Additionally, education officials have emphasized the importance of regularly checking the official admission portal for real-time updates, changes in deadlines, and announcements regarding college-specific instructions. Failure to stay informed may lead to missing key actions such as document uploads or fee payments, which are strictly time-bound. Help centers at schools and district-level facilitation units are continuing to offer guidance, particularly for students in rural pockets or those facing connectivity challenges.

The education department is reviewing Round 1 feedback to improve upcoming CAP rounds. Plans include boosting digital infrastructure in weaker zones and enhancing multilingual support. Authorities believe the evolving digital system can help ensure fair access across Maharashtra.



## MHT CET 2025 Counselling Registration Deadline

The counselling process of the Maharashtra Common Entrance Test (MHT CET) 2025 is in a critical stage with the registration process of applicants interested in the upcoming rounds also coming to the end with the deadline being July 8, 2025. The qualified aspirants requiring engineering, pharmacy and allied professional courses are required to upload the documents along with making online registration and complete the counselling fees so as to have access to seat allotment.

Directorate of Technical Education (DTE) Maharashtra has simplified the counselling procedure in such a way so that it is transparent and efficient. To do so, candidates need to go to the official MHT CET counselling portal to fill in their surveys. Once the candidates are registered, they will be in a direct position to enter their choice of course and colleges that they are willing to join and this will be taken into consideration when allocating the seat.

Maharashtra document verification centers have been established in which candidates will be required to submit the original documents like MHT CET scorecard, SSC and HSC mark sheets, domicile certificates, and caste/category certificate including the personality test. Verification is a mandatory process prior to allotment of seats. The process will also be a merit-based seat

allotment counselling process and the candidates are requested to be well updated with all the counselling process and results through official notifications. Failure to register within the deadline period means that he or she will be disqualified during the counselling rounds. This is a heartbreaking deadline to thousands of students who aim to become successful in knowing admissions in revered engineering and pharmacy institutes in the state of Maharashtra. The applicants are encouraged to go ahead and make sure that they meet all the requirements so that at the last minute, things do not go haywire.

To help ease the stress on students and parents, several guidance cells and help centers have been set up at district and college levels. These centers assist with documentation, portal access, option form filling, and understanding eligibility norms, especially for candidates from rural areas or underrepresented communities. The initiative has been widely appreciated for making the complex process more approachable and inclusive. Authorities urge applicants to regularly check the MHT CET portal and notifications, as any data errors or delays may lead to seat allotment issues.

## Maharashtra Scholarship Exam Results Released for Class 5 and 8; Merit List Soon

The Maharashtra state government has declared the results of the scholarship examination held by the state government among the students of Class 5 and Class 8 officially. The government has restated its commitment towards the expansion of scholarship programs and making them more widespread. 
In addition to the scholarship benefits, the education department plans to organize orientation and awareness sessions in schools to

Officials have further noted that data collected from this year's examination cycle will be analyzed to identify trends in participation, subject performance, and regional gaps. This will guide future reforms and help the state to target educational support in areas with lower engagement or resource access. By doing so, the government aims to make the scholarship model more data-driven, equitable, and impactful in the years to come.

In the coming months, the state education department is expected to release performance analytics by region, gender, and category to understand participation trends and identify underserved groups. These insights will help shape future outreach campaigns and possibly influence revisions in the exam framework. The government aims to not only reward excellence but also provide a stepping stone for children from disadvantaged sections to pursue higher education with confidence.

Special focus will also be given to regions with consistently low participation to ensure targeted support and resource allocation.



## Maharashtra Considers Scholarship Exams Return to Class 4 & 7

There is a policy turnabout being discussed by the Maharashtra education department of reversion of the scholarship examination of Classes 4 and 7 in place of Classes 5 and 8 structure as is presently the case.

This proposal, which is one of the topics of a meeting held on July 5, 2025, is motivated by the sudden drop in student involvement over some years. Having attracted approximately 1.5 million such applicants in the past, current registrations have almost dropped to 1 million, and there are concerns that students have lost interest in the exams and no longer find relevance in the existing formats. The transition would revert the examinations to the lower grades, which are viewed effectively in motivating the young learners and instilling early academic culture.

Teachers in smaller schools (village-level schools) stress that Classes 5 and 8 scholarship exams usually leave behind a large number of students due to structural constraints, including the lack of classes beyond Class 8 in village schools. The previous formats had experienced wider involvement, especially in the rural regions where only Grades 1–7 were offered in local schools, and students had to travel to take preparation exams for the next level. In addition to the advantages of accessibility, the stakeholders also refer to the motivation: younger students gain confidence through early success, and the examination serves as a merit-based incentive at an earlier stage of the entire academic experience.

Teachers also suggest that there needs to be a better examination design, which would

include less dependence on rote learning and more objective testing and scholarship reward at an early age. This would align with the NEP's focus on promoting critical thinking and sustainable academic support systems.

Many educationists argue that the current Class 5 and 8 scholarship system fails to account for the structural realities in backward areas and has unintentionally widened the participation gap. They point out that the curriculum load in upper primary levels, combined with exam pressure, often demotivates students—especially those without access to tuition or proper academic resources. Shifting the scholarship window earlier could ease this pressure and level the playing field for first-generation learners.

Experts suggest adding digital tools, aptitude-based tests, and local language options to the revamped exam system. These changes aim to boost participation among tribal and marginalized groups. A final decision will follow statewide consultations, potentially reshaping Maharashtra's talent development approach.



## B.Pharmacy/Pharm.D Admission Registration Begins

The Maharashtra State Common Entrance Test (CET) Cell has announced that the online counselling and interaction process for admission to B.Pharmacy and Pharm.D courses for the academic year 2025-26 has officially commenced.

As per the latest update, the application form filling process will begin on July 7, 2025, and will remain open until July 14, 2025, offering students a seven-day window to register, upload documents, and pay the necessary application fee.

Admissions to these professional courses will be based on candidates' performance in either the MHT-CET or the NEET examination. Eligible candidates can secure admission to government-aided, government-run, and privately funded pharmacy institutions across Maharashtra. To apply, candidates must log in to the official MHT CET admissions portal, fill out the application form accurately, upload all required documents in the prescribed format, and pay the registration fee online.

The eligibility criteria include having passed the HSC (Class 12) examination with subjects Physics, Chemistry, and Biology or Mathematics. Only candidates who fulfill these criteria and have valid entrance test scores will be considered for the counselling and admission process.

Following registration, the document verification process will be held from July 8 to July 15, 2025, at designated Facilitation Centers (FCs) across the state. Students must carry original and photocopies of essential documents including the MHT CET/NEET scorecard, HSC and SSC mark sheets, Aadhaar card, school leaving certificate, domicile certificate, caste/category certificate (if applicable), non-creamy layer certificate (if

required), and disability certificate (for PwD candidates). Proper document verification is mandatory for seat allotment.

The seat allotment process will be strictly merit-based, taking into account scores in entrance examinations and qualifying exams. After seats are allotted, candidates will be required to confirm their admission by paying the prescribed course fee within the stipulated deadline. Failure to do so may result in cancellation of the allotted seat and forfeiture of the opportunity in further rounds.

This admission cycle is particularly significant due to the increasing demand for skilled professionals in pharmaceutical sciences, especially in the backdrop of rising healthcare needs. The state government has also announced scholarship schemes and fee concessions for eligible students from economically weaker sections (EWS), reserved categories, and rural/tribal backgrounds, to promote access to higher education in the pharmacy sector.

Candidates are advised to apply early to avoid last-minute technical issues and allow time for corrections during document verification. Help centers and helplines are available for assistance. Regularly check the official portal (<https://cetcell.mahacet.org>) for updates on merit lists, seat vacancies, and counselling schedules.



## NEET BAMS 2025 Admissions to Begin Soon: Here's What Aspirants Should Know

Aspiring students of Ayurvedic medicine (BAMS) across India can now start preparing for the next step in their academic journey, as the counselling process for BAMS admissions in 2025 is expected to begin in mid-July. These admissions are based on the NEET UG 2025 results, and will be conducted through both All India Quota (AIQ) under the Medical Counselling Committee (MCC) and respective state counselling portals.

According to last year's trends, the closing ranks for securing a seat in government BAMS colleges typically fell between AIR 30,000 to 80,000, depending on the state and category of the candidate. This range gives hopefuls an idea of where they might stand this year, though exact cut-offs can vary.

To be eligible for BAMS admissions, candidates must:

- Have qualified NEET UG 2025
- Completed Class 12 with Physics, Chemistry, and Biology
- Achieved a minimum of 50% aggregate marks (with 40% required for reserved category candidates)


The admission process involves a few critical steps:

1. Register online at the official MCC website ([mcc.nic.in](http://mcc.nic.in)) for All India Quota seats, or on individual state counselling portals for state quota seats.

2. The registration window is expected to open by late July 2025.
3. Counselling will take place in multiple rounds, including mop-up rounds and stray vacancy rounds, continuing through August 2025.

Aspirants are strongly advised to check previous year's cut-off ranks on the official MCC portal to get a realistic understanding of the colleges they may qualify for in 2025. As seat availability and demand can vary, being informed will help students strategically prioritize their college and course preferences during counselling.

This year's counselling season is expected to be highly competitive, with Ayurveda gaining increasing popularity as a professional path due to its integrative approach to healthcare and growing opportunities in both public and private sectors. Students should stay updated through official announcements and begin preparing the required documents in advance to ensure a smooth and timely application process.



## CET Admissions Progress, but Delays Worry Students

The Maharashtra CET Cell has begun the admission process for nine prominent professional courses, including engineering, law, MBA, MMS, and physical education. However, the absence of finalized schedules for other key undergraduate programs such as BBA, BCA, pharmacy, architecture, nursing, and design is causing increasing concern among students and parents alike.

Despite the smooth rollout of the initial courses, students awaiting updates on the remaining streams are facing uncertainty and stress, especially those who have already completed entrance tests or pre-registration steps. Many are unable to make informed academic decisions without knowing counselling dates, merit list timelines, or seat allotment procedures.

The CET Cell, in its recent statement, acknowledged the delays and attributed them to final-stage reviews of intake capacities and inter-departmental coordination. Officials assured that announcements will be made shortly, and advised aspirants to frequently check the official website for real-time updates.

In parallel, the NEET-MDS counselling process for postgraduate dental admissions is already underway. Registrations concluded on July 3, and the provisional merit list was released on July 4. The first round of seat allotment is scheduled for July 8, giving dental students more clarity than those in UG streams.

In the absence of a centralized and synchronized admission calendar, many colleges are also unsure about their own course-wise timelines, which is further complicating the planning process for students. This uncertainty is especially tough on candidates trying to balance multiple admission options across streams, leading to increased anxiety and the possibility of missing out on other opportunities.

Stakeholders have emphasized that even a tentative schedule for pending courses would go a long way in easing pressure. Suggestions include issuing a phase-wise update, with tentative timelines for each program, to help students align their preparation and documentation. Timely communication from the CET Cell is seen as vital to restoring confidence in the system and ensuring equitable access to academic planning for all aspirants across Maharashtra.

Parents and school authorities have also raised concerns about the cascading effect of delays on hostel arrangements, fee planning, and academic preparedness.



## Maharashtra ITI 2025: First Merit List Out, Nashik Shines in Vocational Admissions

In a major update for vocational education in the state, the Directorate of Vocational Education and Training (DVET), Maharashtra, has officially released the first merit list for Industrial Training Institute (ITI) admissions for the academic year 2025-26. This announcement marks a critical step in the admission process for thousands of students seeking skill-based education across Maharashtra.

The first-round merit data has revealed significant regional performance disparities. Nashik district has taken the lead, with the highest number of top-ranked applicants securing spots in the initial allotment. According to officials and local educators, Nashik's performance can be attributed to a combination of targeted awareness drives, greater school-level counselling, and a growing interest in practical skill development programs among youth in the region.

For the candidates who find their names on this list, this is a pivotal academic milestone. These students must now complete time-bound admission formalities, including:

- Submission of original and photocopied documents
- Verification of educational and identity credentials
- Payment of required admission fees

Failure to comply with the deadlines may result in the cancellation of allotted seats or exclusion from future rounds of counselling. As a preventive measure, DVET has urged all candidates and their guardians to follow the instructions provided on the official ITI admission portal carefully. Dedicated

facilitation centers and grievance redressal teams have been set up across districts to assist students who may face technical issues or confusion during the process.

Beyond the numbers, this year's ITI admission cycle is gaining attention for broader reasons. As India continues to strengthen its focus on skill-based education and employability, ITI programs are becoming increasingly popular—not just in rural areas, but also among urban youth who are looking for alternative, career-ready pathways to employment. With the expansion of government-led skilling initiatives and partnerships with industry bodies, ITI graduates are finding more opportunities in sectors like automotive, electronics, construction, plumbing, healthcare, and refrigeration, among others.

Officials report a rise in ITI applications from first-generation learners, girls, and underprivileged students, signaling greater inclusivity in vocational education. Many see ITIs as a path to financial independence where higher education was once inaccessible. The DVET has confirmed more merit-based allotment rounds in the coming weeks, urging students to stay prepared and update their preferences. Stakeholders are calling for region-specific outreach, early orientation, and digital support to ensure equal access across Maharashtra. The evolving admission trends highlight a shift toward aligning education with workforce demands.



## DFCCIL Admit Card 2025 Released: CBT-1 Exams on July 10 & 11 – Download Hall Ticket

The Dedicated Freight Corridor Corporation of India Limited (DFCCIL) has officially released the admit cards for the 2025 recruitment examination for various technical and managerial posts. Candidates who applied for these positions can now download their admit cards from the official website, [www.dfccil.com](http://www.dfccil.com), starting Monday, July 7, 2025. This development marks an important step in the recruitment process and allows aspirants to begin final preparations for the upcoming Computer-Based Test (CBT Stage 1), scheduled for July 10 and 11, 2025.

The recruitment examination will be held to fill multiple vacancies across departments, including posts such as Executive (Signal & Telecommunication), Executive (Civil), Executive (Electrical), Junior Manager (Finance), and Multi-Tasking Staff. The CBT Stage 1 will consist of 100 multiple choice questions (MCQs). Each question carries one mark, and the total duration of the test is 90 minutes. For candidates with benchmark disabilities (PwBD) availing the scribe facility, the duration will be 120 minutes. The examination will follow a negative marking system, where 0.25 marks will be deducted for each wrong answer. The objective of the test is to assess candidates' subject knowledge, logical reasoning, and general aptitude relevant to the applied post.

To download the DFCCIL Admit Card 2025, candidates need to visit the official website and click on the link titled "Download Admit Card for Recruitment Exams for various posts under Advt. No. 01/DR/2025" available on the homepage. After logging in with the correct credentials, they can view, download, and print the admit card for future reference.

Candidates must ensure they follow the important instructions mentioned on the admit card. These include reporting well in advance of the exam time, not carrying any restricted items like mobile phones, smartwatches, or calculators, and following any COVID-19 safety guidelines that may be applicable. These certifications are especially valued in central and state government recruitments, PSU placements, and private IT firms.

To appear for the July 2025 NIELIT exams, candidates must complete registration, submit forms, and download their admit cards—mandatory for entry along with a valid photo ID. NIELIT advises students to verify subject codes, dates, and shift timings, especially in multi-shift centers. With the date sheet out, focus should now shift to final revisions, balancing theory and practicals for A, B, and C levels. These exams are key to improving job prospects and qualifying for government opportunities, so students should prepare with focus and ensure all logistics are in place. The Telangana Council of Higher Education (TGCHE), formerly known as TSCHE, is set to declare the results of the Telangana State Integrated Common Entrance Test (TS ICET) 2025, July 7. Candidates who appeared for the exam can download their rank cards from the official website, [icet.tgche.ac.in](http://icet.tgche.ac.in), once the results are officially announced. Along with the result, the final answer key for the examination will also be released.

The TS ICET 2025 exam was conducted by Mahatma Gandhi University, Nalgonda, on behalf of TGCHE. The entrance exam took place on June 8 and 9, 2025, in two shifts each day — from 10:00 AM to 12:30 PM and from 2:30 PM to 5:00 PM. This exam is held annually for admissions into MBA and MCA programmes offered by various universities and affiliated colleges in the state of Telangana.



## Canada Raises Financial Bar for International Students Starting September

In a significant update that could affect thousands of aspiring students, Immigration, Refugees and Citizenship Canada (IRCC) has increased the financial proof required for study permit applications. Starting September 1, 2025, international students must now show they have access to at least CAD 22,895, up from CAD 20,635.

This revised threshold is designed to better reflect the rising cost of living across Canada and ensure that students are financially equipped to support themselves for at least one year of study. The new rule will apply to all provinces except Quebec and will impact all study permit applications submitted on or after September 1.

### Universities Brace for Change

Post-secondary institutions across Canada are adjusting their admission materials to reflect the revised financial guidelines. International student advisors are cautioning applicants to start their planning early, factoring in the increased living expense estimates while budgeting for tuition and travel.

“This adjustment may tighten financial planning for many families,” said Michael Chen, Director of International Admissions at a major Vancouver-based university. “But Canada's strong post-study work options and immigration pathways still make it a top choice.”

Many education consultants believe the higher financial threshold could shift student interest toward countries with more affordable living costs or flexible visa systems.

However, they also note that Canada's transparency in setting clear financial expectations provides a sense of stability compared to more abrupt changes seen elsewhere.

“Clarity in visa requirements helps students avoid unpleasant surprises,” said Anika Mehta, a senior advisor at a global student mobility firm. “While the bar has been raised, it encourages better preparation, and families who plan ahead can still make Canada a viable option.”

**Global Visa Shifts: A Tougher Landscape**  
Canada's move is part of a broader trend among top study destinations. Just this month, Germany scrapped its “remonstrations” process—a mechanism that allowed rejected visa applicants to appeal—replacing it with stricter submission criteria.

Meanwhile, the UK has also introduced major changes. From July 22, 2025, the popular Graduate Route visa will be cut from two years to just 18 months, and new compliance regulations for education sponsors will be enforced.

### What It Means for Future Students

With multiple countries tightening immigration policies and increasing financial scrutiny, the road to studying abroad is becoming more challenging. However, Canada's reputation for post-study work permits (PGWP) and clear routes to permanent residency continues to draw global interest.

Experts advise prospective students to start early, build a realistic financial plan, and pay close attention to changing visa policies.

## Studying Abroad in 2025? It's Less About Universities, More About Immigration Strategy

For today's Indian students, choosing where to study abroad isn't just about picking a top university—it's about navigating a complex web of immigration policies, visa rules, and long-term residency options.

In 2025, the dream of international education is still alive, but the game has changed. Over 1.8 million Indian students are studying overseas, yet the road ahead is lined with new hurdles, as several countries tighten their immigration and visa norms.

Countries like Canada, the UK, Germany, and Australia—once the most sought-after study destinations—have all introduced stricter rules this year. From financial requirements to work permit limitations, governments are reshaping their international student strategies, with broader immigration goals in mind.

### Tightening the Screws

The UK recently reduced its popular Graduate Route post-study work visa from 2 years to just 18 months, a policy change set to take effect on July 22. Over in Canada, students applying for a study permit after September 1, 2025, will need to prove access to over CAD 22,000, up by CAD 2,260, along with facing stricter scrutiny for certain private colleges.

Germany has overhauled its visa appeal process, eliminating the previously available “remonstrations” mechanism and replacing it with tighter documentation requirements. These changes reflect a broader shift:

education policies are being shaped more by immigration control than academic diplomacy.

### Students Shift Priorities

As visa landscapes evolve, education experts say students and parents are starting to look beyond just world rankings and course offerings. Permanent residency pathways, transparent immigration rules, and employment opportunities are becoming bigger deciding factors.

“It's not just about where you want to study,” said Arvind Bhatia, Director at Mumbai-based consultancy StudyMap Global. “It's about where you can see a stable future.”

As traditional destinations get more selective, countries like Ireland, New Zealand, and even Scandinavian nations are seeing rising interest. Their student-friendly immigration policies, scholarships, and PR options are turning heads.

### A New Era of Global Education

For Indian families weighing the pros and cons of studying abroad, experts recommend a holistic approach: understand the full visa journey, budget for increased financial requirements, and prioritize long-term security over short-term prestige.

The global classroom is still wide open—but in 2025, the smartest students are those who study the immigration rules just as closely as they study the curriculum.

## Germany Gets Tougher on Student Visas as International Demand Surges

Germany is tightening its student visa regulations amid a record influx of international applications, signaling a more cautious stance toward academic migration. The changes, which took effect on July 1, are particularly impactful for students from India, the country's largest source of non-EU student applicants.

At the heart of the reform is the abolition of the remonstrations process, a widely used appeal mechanism for students whose visa applications were denied. In its place, a more formal review panel system has been introduced—one that demands stricter documentation, certified financial records, and upfront language proficiency evidence, even at the appeal stage.

The German Federal Foreign Office said the move is intended to curb misuse of student visas and to uphold the credibility of the country's education system. According to officials, student visa applications from outside the EU jumped by 22% over the past year, with Indian applicants leading the surge.

### New Visa Rules Raise the Bar

In addition to replacing the appeal process, Germany has increased the annual minimum block account requirement from €11,208 to €12,324, citing inflation and rising living costs. Authorities have also begun closer scrutiny of student finances, and in many cases, pre-departure interviews are now being reinstated.

Students applying to English-taught programs are under particular pressure, as they must now provide stronger academic justifications and clearer course alignment proof—all before boarding a plane.

### Backlash from Education Advisors

Back in India, the reaction has been swift. “The removal of the remonstrations option hurts genuine applicants,” said Swati Mehra, senior consultant at GlobalEd Gateway in Delhi. “A small error in paperwork now means a longer wait or starting from scratch.”

Though Germany remains a top destination thanks to its tuition-free public universities and strong post-study work options, many education experts fear that these new barriers could deter deserving students—especially those hoping for a more flexible visa pathway.

### A New Era of Controlled Entry

As competition among international students intensifies, Germany's stricter rules reflect a shift toward regulation over reach. While the country still offers high-quality education and strong employment prospects, students will now need to navigate a more bureaucratic and rigorous visa process to get there.

For future applicants, the message is clear: studying in Germany is still possible—but it will require meticulous planning, financial readiness, and uncompromising documentation from day one.



## Australia's Student Visa Fee Now Highest Among English-Speaking Nations — Indian Students Weigh the Impact

In a major immigration policy shift, Australia has increased its student visa application fee by a steep 25%, effective July 1. The new charge of AUD 2,000 (approximately ₹1.12 lakh) makes it the highest visa fee among major English-speaking study destinations, raising eyebrows among students and education consultants alike.

The move is part of a larger immigration overhaul, as the Australian government works to regulate migration numbers, manage population growth, and generate additional revenue.

### What's Changed?

- The increased fee applies only to primary student visa applicants — dependents and spouses are not affected.
- The government expects to collect an estimated AUD 760 million through this change over the next four years.
- The hike accompanies other visa reforms, including stricter financial proof, tighter work rights, and higher entry thresholds for skilled migrants.

### Reactions on the Ground

Despite the increase, experts believe it won't drastically reduce interest in studying in Australia.

"For students already planning to spend AUD 55,000 to 85,000 annually on tuition and living, this additional AUD 400 is

noticeable but unlikely to be a deal-breaker," said Saurabh Arora, CEO of student accommodation platform University Living, in a recent interview with Business Standard.

In fact, Australia continues to be a favorite among Indian students. Student arrival figures in February 2025 were strong, reflecting the country's enduring appeal due to post-study work rights, world-class education, and residency options.

### A Bigger Immigration Reset

This visa fee hike is just one piece of a broader July 1 immigration reform package. The government has also rolled out:

- New skilled visa categories
- A restructured partner visa system
- Changes to age limits for partner visa applicants

The aim is to better align migration policies with Australia's workforce needs and ease pressure on infrastructure and services. Planning Ahead

While the revised fee does add to the upfront cost of studying in Australia, the country remains attractive for its career growth opportunities and clear pathways to permanent residency.

Experts are urging Indian aspirants to plan early, keep financial documentation in order, and stay updated on evolving visa policies to ensure a smooth application process.

## Biotech is Booming: Indian Students Flock Abroad for Future-Ready Degrees

Students now value access to labs, research funding, and industry links over brand names. "They're pragmatic," said Chaturvedi. "They want to enter the bioeconomy workforce and make real impact."

Popular choices include the US, UK, Canada, Germany, Australia, and Singapore — thanks to work rights, assistantships, and industry exposure.

### Funding the Dream

Many fund biotech degrees through loans, scholarships, and assistantships. In Canada, loans cover 60–70%; in the US, STEM OPT makes it attractive post-study.

### Career Paths

Graduates move into roles like research scientists, bioinformaticians, and regulatory specialists, with salaries ranging from \$80,000 to \$120,000 in the West.

### Summary

India's biotech talent is going global — aiming for labs, not just lecture halls — ready to innovate across healthcare, agriculture, and sustainability.

## Harvard Students Urge University to Stand Firm Against Trump Administration Pressure

Tensions are rising at Harvard University as over 200 students have signed an open letter demanding that the university resist any political pressure from the Trump administration, amid ongoing negotiations between the institution and federal officials.

The letter, titled "To Harvard from Its Students," was circulated on Friday by the student-led group Harvard Students for Freedom, and has since garnered 197 public signatures and 29 anonymous endorsements from current undergraduate and graduate students. The group, formed earlier this year, voiced deep concerns that the university's autonomy could be compromised for political appeasement.

"Harvard is not Harvard if it is ruled over by the Trump administration," the letter declares.

### A Call for Academic Independence

The student petition comes amid growing speculation about a possible agreement between Harvard and the Trump administration — a deal that former President Trump recently teased as "historic" on social media. While the university has neither confirmed nor denied the nature of the discussions, it has publicly outlined steps taken to address antisemitism and encourage viewpoint diversity on campus.

Still, students worry that those efforts may come at the cost of academic freedom, faculty independence, and student rights.

"If a deal is indeed close to being reached," the letter reads, "we sincerely hope that it is because the Trump administration has backed down — not because Harvard has caved."

### Specific Student Concerns

In particular, the letter warns against:

- Removing faculty members under political pressure
- Modifying course content to align with government viewpoints
- Disciplining students for exercising peaceful free speech
- Sharing disciplinary records of international students, which could lead to immigration consequences

"A deal must not involve turning over the disciplinary records of international students," the letter warns, "risking ideological deportation. Doing so would set a dangerous precedent for the entire country."

The students argue that such compromises would violate the principles of higher education and set a worrying example for other academic institutions across the U.S.

### University Response So Far

While Harvard has not responded directly to the open letter, it has reiterated in previous statements that protecting academic freedom and upholding institutional values remain top priorities.

### What's Next?

As students grow increasingly vocal, all eyes are on Harvard's leadership. For now, the message from students is clear: Hold the line. "We know Trump's strategy," the letter states. "Give him an inch and he'll take a mile."



## AP EAMCET 2025 Counselling Begins for 3.62 Lakh Eligible Students

The Andhra Pradesh State Council of Higher Education (APSCHE) has begun the AP EAMCET 2025 counselling process for admissions into engineering, agriculture, and pharmacy undergraduate courses across the state.

With thousands of students relying on the EAMCET route for higher education, the successful execution of this counselling phase is critical. APSCHE has assured students that support teams will be available to assist with technical and procedural concerns throughout the process.

These developments mark a crucial turning point in the academic calendar, as students across Andhra Pradesh begin their transition from entrance exams to college admission.

## Record 1.5 Lakh Students Apply for 1.1 Lakh Polytechnic Seats in Maharashtra

According to DTE Director Dr. Abhay Wagh, "Diploma education is no longer a fallback option. Students today prefer hands-on, industry-ready training that ensures employability without necessarily going through the full four-year degree route."



Institutes in urban clusters like Mumbai, Pune, Aurangabad, and Nagpur have received the highest number of applications. Nagpur division alone received 14,000 applications for 12,500 seats in its 51 polytechnic colleges.

### What Students Should Know

- Document verification and grievance redressal will take place between July 7 and July 12.
- Round 1 seat allocation will begin from July 13, followed by three more CAP rounds through mid-August.
- Students must complete their admission formalities within a day or two of seat allotment, or risk forfeiting their slot.

### Growing Preference for Diploma Courses

In recent years, Maharashtra's DTE has introduced bilingual course modules, internship-linked training, and industry partnerships through its "K-Scheme" to improve outcomes.

Polytechnic graduates are increasingly placed in manufacturing units, IT services, MSMEs, and R&D labs—often with salary packages on par with engineering graduates.

Many students from rural and semi-urban areas are viewing diploma programs as a faster, more affordable gateway to the workforce, especially with rising living costs and competitive entrance exams for degree courses.

The flexibility and lower cost of polytechnic education make it an attractive alternative for families prioritizing early employment.

With competition reaching record highs, education experts believe this trend signals a shift in mindset, where diploma education is now being seen as a direct pathway to employability, entrepreneurship, and future upskilling in emerging tech.

## CISCE Launches 'Active CISCE' to Track Student Fitness Nationwide

What sets this initiative apart is its comprehensive scope — the card will also document lifestyle factors like sleep quality, screen time, nutrition patterns, hydration habits, and sports participation or achievements. The idea is to create a 360-degree profile of a student's physical health, integrated seamlessly into their educational records.

### Academic Linkages and Progress Tracking

In a first-of-its-kind move, CISCE has declared that fitness benchmarks will now play a role in academic progression. Specifically, physical wellness indicators will be considered during promotions from Class 8 to 9 and Class 10 to 11. This is intended to incentivise regular participation in fitness activities and embed the importance of well-being into the academic mindset of both students and educators.

The digital portal will act as a bridge between schools and families, offering monthly fitness reports and alerts to help identify health concerns early. Its user-friendly design enables real-time tracking and supports joint efforts by teachers and parents to improve student well-being.

To support implementation, CISCE has collaborated with health experts to create age-appropriate, video-based activity routines. These can be used during PT classes, assemblies, or short breaks, making fitness accessible even in schools with limited resources.

The initiative aligns with the National Education Policy (NEP) 2020, which promotes wellness, emotional balance, and life skills alongside academics.

Educators have welcomed 'Active CISCE' as a timely step to tackle growing issues like childhood obesity, screen addiction, and mental fatigue.

"For years we focused only on academics. This gives us a structured way to support overall well-being," said Mrs. Ritu Banerjee, a school principal in West Bengal.

Looking ahead, CISCE plans to integrate AI tools by 2026 to track long-term health trends and provide personalised fitness recommendations. If successful, the model may be extended to other boards.

By embedding wellness into daily school life, 'Active CISCE' is redefining schools as hubs of holistic growth. Its success could mark a new chapter in how education systems nurture both mind and body.

## Telangana Offers Over 1.07 Lakh Engineering Seats Across 171 Colleges

The Telangana State Council of Higher Education (TSCHE) has officially announced the commencement of the Engineering, Agriculture, and Pharmacy Common Entrance Test (EAPCET) 2025 counselling process. A total of 1,07,218 seats are available across 171 participating colleges this academic year.

The EAPCET seat allotment is part of Telangana's broader push to digitize and simplify higher education admissions while maintaining academic quality.

As the counselling process enters its crucial phase, students are encouraged to stay informed, follow official updates, and act within deadlines to secure their desired academic paths in one of India's fastest-evolving higher education ecosystems. 




