## Final Opportunity for Former Delhi University Students to Complete Degrees

Delhi University (DU) has announced a special one-time chance for its former students to complete their pending degrees, calling it the "final opportunity" of its kind. This move is aimed at helping those who, for various reasons, could not clear their examinations or finish their coursework in the allotted time. The opportunity covers students who had enrolled in undergraduate programs between 2012 and 2019, as well as postgraduate and professional courses between 2012 and 2020.

According to the official notification, eligible students will be permitted to reappear for a maximum of four papers in order to complete their degrees. This provision offers a vital lifeline to many students whose academic and professional journeys have stalled due to incomplete qualifications. DU authorities have clarified that after this, no further special chances will be provided, making this the last and decisive opportunity for such students to regularize their academic status.

The application process has already begun, with the deadline set for September 1. Interested candidates are required to submit their applications along with a fee of ₹5,000 per paper, which will cover the examination and administrative costs. The university has stressed the importance of adhering to deadlines and ensuring that all required documents are submitted correctly to avoid disqualification. University officials have highlighted that this initiative not only provides a long-pending solution for students but also helps uphold the academic integrity of DU. Over the years, several students had approached the university with requests to allow them to complete their degrees, citing personal, financial, or healthrelated reasons for their academic gaps.

The administration hopes that this final window will bring closure to such pending cases while ensuring accountability and fairness.

Education experts have welcomed the move, noting that completing a DU degree holds significant value in both national and international job markets. They have urged eligible students not to miss this chance, as it may open up new career opportunities and allow them to pursue higher studies without obstacles. At the same time, teachers and counselors are advising students to prepare diligently for their re-appear exams, as this will be their last opportunity to secure a Delhi University degree. Meanwhile, several student associations have praised the university for taking this step but have also demanded that the examination fees be reconsidered, arguing that ₹5.000 per paper may be unaffordable for many students. They have suggested a subsidized rate or financial assistance for economically weaker candidates to ensure that deserving students are not left behind. The administration has yet to respond to these appeals, but the debate has added another dimension to the ongoing discussion around accessibility and inclusivity in higher education.







# NEET UG 2025 Counselling Registration Begins

The Medical Counselling Committee (MCC) students to register early, double-check their has officially commenced the registration process for the first round of NEET UG 2025 counselling, marking a crucial step for lakhs of aspiring medical students across the country. Students who successfully cleared the NEET UG exam can now apply to participate in the national-level seat allotment process for admission into MBBS, BDS, and other undergraduate medical and dental courses

The registration window is open till August 25, 2025, which is also the deadline for the payment of counselling fees. The results of the first round of seat allotment will be declared online on the official MCC portal. Students who are allotted a seat will then need to report to their respective colleges within the given timeframe to confirm their admission by submitting documents and paying the required fees. Authorities have advised candidates to keep track of all important dates and official notifications on the MCC website to avoid missing deadlines. Since NEET counselling is conducted in multiple rounds, those who do not secure a seat in the first round will still have opportunities in subsequent rounds. However, MCC has urged

## Delhi University Announces Final Phase of Undergraduate **Admissions**

Delhi University (DU) has officially launched the final phase of undergraduate admissions for the academic session 2025-26, offering one last chance to students who were unable to secure seats in the earlier rounds. This move comes as part of DU's efforts to ensure that all available seats are filled before the academic year begins.

According to the DU admission committee, this phase is being conducted under the Common Seat Allocation System (CSAS), which relies on candidates' CUET-UG 2025 scores. The process will focus primarily on filling the remaining vacant seats across DU's affiliated colleges. Officials highlighted that while most seats have been taken, some popular programs still have openings due to withdrawals, cancellations, and students failing to confirm admissions in earlier rounds.

The admission portal has reopened for fresh registrations as well as preference reordering, and it will remain active until August 25. During this period, applicants can rearrange their college and course preferences to improve their chances of securing a seat. DU officials have urged students to carefully check the updated seat matrix before locking in their final preferences. The results for this round of seat allotment will be declared on August 28, after which selected candidates will

have until August 30 to confirm their admissions by paying the required fee uploading documents. The university has made it clear that this will be the final admission cycle for the current academic session, and no further spot rounds will be organized after this stage.

So far, DU has admitted over 70,000 students across its prestigious colleges, but a few vacancies remain in soughtafter programs in the fields of Humanities, Commerce, and Science. Education experts suggest that the closing ranks in this round are likely to rise sharply, as students make a lastminute push to secure a seat in top colleges like Hindu College, Miranda House, and SRCC.

The university has advised applicants to act promptly and avoid last-minute delays, as the competition in this phase is expected to be intense. Candidates are also reminded to keep all necessary documents ready for verification to ensure a smooth admission process. With this final round, DU aims to wrap up its UG admissions cycle for 2025–26, marking the end of an extended admission season.

The Joint Entrance Examination (JEE) Advanced 2025, organized by IIT Kanpur on May 18, 2025, concluded with the official results being released on June 2, 2025. Out of nearly 1.8 lakh registered candidates, 54,378 successfully qualified for admissions to the prestigious Indian Institutes of Technology (IITs). The examination continues to stand as one of the world's toughest undergraduate entrance tests, determining the academic futures of India's brightest engineering aspirants.

#### **Top Performer: Historic Achievement**

- All India Rank (AIR) 1: Rajit Gupta from Kota emerged as the national topper with a record-breaking score of 332 out of 360 marks.
- Rajit is the first-ever local student from Kota, the city globally renowned as India's coaching hub, to clinch the top rank. Despite Kota's reputation for producing toppers through its competitive coaching culture, no student from within the city had previously held AIR 1 in JEE Advanced.

- Subject-wise analysis revealed Mathematics was the toughest section, while Chemistry was moderately easier. and Physics balanced conceptual and application-based questions.
- This reinforced the exam's shift toward conceptual depth over speed-solving, testing analytical reasoning more than rote memorization.

Focus areas include sustainable energy, artificial intelligence, advanced materials, and disaster resilience—fields where India and Japan already have strong expertise.

• Global Immersion:

Earlier in March 2025, IIT-B hosted a Global Immersion Program for Tohoku students, which set the foundation for this collaboration.

• Japan is a global leader in cutting-edge technology and disaster management research, while IIT Bombay brings

strengths in engineering, applied sciences, and innovation ecosystems.

· The JIE will provide students access to labs, joint supervision, and exchange opportunities in both countries.

## University of Southampton Opens First Foreign On-**Campus Program in Gurgaon Under New UGC Rules**

## WhatHappened?

The University of Southampton, a renowned UK institution and founding member of the Russell Group, officially inaugurated its first overseas campus in Gurugram, within the International Tech Park, Sector 59. This is the first foreign university campus in India under the UGC's 2023 regulations, marking a pivotal moment in higher education globalization.

This launch symbolizes a major step in the internationalization of Indian education under NEP 2020 and opens doors to "study

abroad at home." It strengthens India–UK academic ties and positions Gurugram as a global education hub.

#### **How It Works?**

• Programs Offered:

Starting August/September 2025, the campus will offer 4 BSc courses (Business Management; Accounting & Finance; Computer Science; Economics) and 2 MSc degrees International (Finance; aligned with UK Management), all academic standards.

• Global Mobility:

Students can spend up to one year at Southampton's UK or Malaysia campuses, ensuring cross-border exposure.

• Faculty recruitment:

Over 75 full-time faculty members with international experience (UK, US, Germany, Japan, Singapore, Australia) will be hired. All must complete the University's Postgraduate Certificate in Academic Practice.

• Facilities & Design:

The campus features multi-functional

teaching spaces, research labs, collaborative zones, and designs blending Southampton's heritage with Indian architectural motifs. Built under the "Triple Helix" model, it encourages academia-industry-government collaboration.

• Admissions & Fees:

Applicants need to submit personal statements, recommendation letters, and academic transcripts; selections include interviews. While fees aren't formally announced, they are estimated between ₹13.2 lakh (BSc) and ₹15.4-19.8 lakh (MSc), lower than UK campus rates (£18,000-33,000). English proficiency test scores (IELTS/TOEFL) are not mandatory.

### Regulatory Info:

The campus was approved following issuance of a Letter of Intent (LoI) in August 2024 under UGC's new regulations for foreign campuses, signed off in 2023. The formal Standing Committee fast-tracked approval within just seven months.

## **Conclusion:**

This launch marks a historic milestone— Southampton Delhi paves the way for worldclass foreign university education within India itself. With robust infrastructure, global faculty, and student mobility, it signals India's emergence as a global knowledge destination, aligning with NEP 2020 and reshaping the landscape of higher education.

## UK Immigration Overhaul: Graduate Route Reduced **Amid Tougher Student Visa Rules**

#### What Changed?

- The UK's Graduate Route visa, which allows international students to stay and work after graduation, is being reduced from 2 years to 18 months for undergraduate and master's students, effective from programs starting in January 2026.
- PhD holders will continue to be eligible for a 3-year visa, pending Home Office confirmation.
- The government also introduced a 6% levy on international student tuition to fund domestic skill and education programs, part of a wider strategy to immigration. reduce net

#### Why It Matters?

- The Graduate Route previously served as a major draw for international students by offering two years of unsponsored work flexibility—an attractive alternative to tightly timed work visas like the U.S. OPT or Australia's post-study work visas.
- · Curtailing this duration may deter prospective students who weigh job flexibility heavily, potentially impacting universities' UK international enrolment and revenue, especially for costly programs like medicine.

#### **How It Works?**

Only PhD students (and above) can bring dependants; all others face limitations mirroring dependency growth from ~20K in 2019 to over 150K in 2023.

The UK has kept its post-study immigration route, but with shorter stay durations, new fee levies, and stricter compliance rules. This marks a shift toward more controlled international education policies, meaning students will face fewer advantages, tighter timelines, and greater scrutiny-making strategic planning more important than ever.

## India-UK Critical Minerals Collaboration: TEXMIN to Open Satellite Campus at IIT(ISM) Dhanbad -VidyarthiMitra News Desk

#### What happened?

Under the India-UK Technology Security Initiative (TSI), the UK and India announced new projects to secure critical-minerals supply chains. As part of this, the Technology Innovation in Exploration & Mining Foundation (TEXMIN) will host a satellite campus at IIT(ISM) Dhanbad to expand R&D, training and innovation capacity. A Rare-Earths-focused UKcomplementary India Critical Minerals Supply Chain Observatory is being set up at GMDC's iCEM in Ahmedabad.

## Why it matters?

Critical minerals (lithium, cobalt, rare earths, graphite, nickel, etc.) are essential for batteries, EVs, wind turbines and electronics. The satellite campus creates a pipeline of Indian researchers and industry professionals trained on secure, responsible mining and processing, while deepening UK-India tech Strategic Importance: and security cooperation.

#### **Key details:**

Investment/Scope:

TSI is a bilateral programme announced in 2024 and marked its first-year update on July 24, 2025; the new Dhanbad satellite campus and the Ahmedabad observatory are listed among concrete deliverables.

• Focus areas:

Exploration tech, sustainability, traceability, supply-chain analytics, and workforce skilling for mines & processing plants.

• Recency:

Indian business media confirmed the Dhanbad campus move on Aug 21, 2025

• Training & Skill Development:

Specialized workshops and training programs for students, researchers, and industry professionals in critical mineral exploration and sustainable mining practices.

• Joint Research:

Collaborative projects on sustainable extraction technologies, recycling, and mineral processing.

Policy Exchange:

Sharing best practices in mining governance, ESG (Environmental, Social, Governance) circular frameworks, and economy approaches.

• Knowledge Hub: Creation of a platform for Indo-UK experts to work on global mineral security issues.

- Strengthens India's ambitions to become a hub for electric mobility and renewable energy.
- Enhances UK-India educational and industrial collaboration in a highdemand technology area.
- Supports long-term sustainability goals by promoting responsible and ecofriendly mining.

#### Japan-Anna University: India-Japan Talent Bridge at **Anna University** -VidyarthiMitra News Desk

What happened?

A delegation of six Japanese companies held a career seminar at Anna University (CEG & MIT campuses) under Japan's India-Japan Talent Bridge programme (METI). More than 300 students attended. At the event Japanese speakers said Japan plans to scale hiring of Indian graduates through this initiative.

#### **Key facts:**

- Event organised under METI's India-Japan Talent Bridge framework; delegation visited Anna University (and scheduled visits to IISc Bengaluru and IIT Gandhinagar).
- · Media reports at the event quoted organisers saying Japan plans to hire up to 50,000 Indian students over the next five years (figure quoted by company/ organiser speakers).
- Companies flagged internships, placement drives and sponsorship for Japaneselanguage training for successful candidates; earlier rounds of Japan-India placements have resulted in campus offers to Indian students (example: Anna University placements to Japanese firms earlier in 2025).

#### Why it matters?

Japan is actively building talent pipelines to address domestic skill gaps (ageing population + tech needs). The Talent Bridge programme is the diplomatic/industry route to create internships, direct hires and academic

partnerships connecting Indian engineering graduates with Japanese employers.

#### Things discussed at India-Japan Talent Bridge seminar at Anna University:

- 1. Seminar Attendance and Organizers Held under METI's India-Japan Talent Bridge Programme, the event was attended by representatives from six Japanese companies and more than 300 students from Anna University (CEG and MIT campuses).
- 2. Job Prospects Communicated Japanese company representatives announced plans to recruit up to 50,000 Indian students over the next five years, highlighting sectors like IT and product development.
- 3. Emphasis Japanese-Language Training

Multiple companies expressly encouraged students to learn Japanese language and culture, indicating that language skills would be considered in future recruitment pipelines.

4. Strategic University Outreach

Anna University officials confirmed plans to pursue dual-degree programs with Japanese universities, as part of its ongoing collaboration with the Talent Bridge initiative.

## Rajasthan's Swami Vivekananda Scholarship Abroad **Stream Restructured for 2025–26**

The Rajasthan government has unveiled Key Updates & Rules for Students significant changes to the Swami Vivekananda Scholarship (SVS) - Study Abroad Stream for the academic year 2025–26. The scheme, which supports meritorious students pursuing higher education overseas, has been restructured with reduced seats, stricter monitoring, and new obligations for beneficiaries.

## What Happened?

The number of scholarships for foreign studies has been reduced from 500 to 150, while 350 seats have been reserved for higher studies in India. Selection for the foreign quota will now take place in three

- Phase 1: August 21 September 20,
- Phase 2: October 21 November 20,
- Phase 3: January 1 January 15, 2026 (only if seats remain unfilled)

#### Why the Change?

The government has stated that the reforms are intended to ensure that taxpayer-funded scholarships benefit the state of Rajasthan directly. With rising costs and limited public resources, the scheme now emphasizes retaining talent within the state after foreign education.

- Employment **Obligation:** Students availing this scholarship must give first preference to jobs within Rajasthan after completing their studies abroad.
- Government **Assignments**: During their academic tenure, students may be asked to carry out comparative studies of foreign government schemes, prepare reports, or provide technical advice to the Rajasthan government.
- Monitoring: Progress Continuation of funding is contingent on annual or biennial progress reports, along with university performance assessments uploaded to the official portal.
- Property & Guarantee Clause: Applicants are required to submit property documents and surety guarantees. This clause has criticized as a barrier for underprivileged students lacking assets.

### Conclusion

The revamped Swami Vivekananda Scholarship scheme signals a shift towards accountability and local benefit in public funding for foreign education. While opportunities abroad remain, students must now navigate tighter regulations, reduced availability, and binding commitments to Rajasthan.



## Delhi Govt Makes AI, Skill Development & Clubs Mandatory in Schools from 2025–26

In a landmark reform aligned with the National Education Policy (NEP) 2020, the Delhi government has announced that from the academic session 2025–26, government schools will integrate Artificial Intelligence (AI), skill development modules, and mandatory student clubs into their curriculum. The move is aimed at equipping students with future-ready skills while ensuring their holistic development beyond academics.

#### **New Curriculum Additions**

From the upcoming session, AI will be introduced as a subject for Classes XI and XII. Students will learn the basics of machine learning, data analysis, and the ethical use of technology, with teachers undergoing specialized training workshops. In addition, at least one student club in every government school will now be compulsory. Options include Literature, Arts, Theatre, Debating, Coding, Sports, and Leadership. Each club will receive direct funding of ₹20,000 from the Directorate of Education to set up activities and events.

#### Yoga, Arts & Leadership Development

The new framework also emphasizes student well-being and creativity. Schools are required to schedule weekly yoga and arts sessions, along with leadership-building activities such as debates, theatre, and community service. Teachers believe this shift will help reduce exam-centric pressure and build confidence among students. Parents too welcomed the reform, noting that modern education must combine skills, values, and innovation to prepare children for future challenges.

#### **Digital & Skill-Based Learning**

The CBSE's planned digital assessment model will be integrated with Delhi schools, ensuring faster, transparent evaluation. Skill development centers in select schools will provide training in robotics, renewable energy, entrepreneurship, and coding, with partnerships from corporates and startups for internships.

#### **Monitoring & Implementation**

To ensure compliance, the government has mandated quarterly activity reports from schools. District-level monitoring teams will review the effective functioning of AI courses, clubs, and extracurricular programs.

#### **Holistic Vision**

Education Minister Ashish Sood said:

"This initiative is not just about subjects—it's about shaping resilient, compassionate, and skilled citizens. With AI, skill training, and extracurriculars, Delhi schools will set a benchmark for holistic education."

#### **Reactions from Schools & Parents**

Teachers have welcomed the reforms, saying that weekly yoga sessions and cultural clubs will help reduce student stress and foster creativity. Parents expressed optimism that these initiatives would ensure their children are better prepared for higher studies and careers. Some parents, however, raised concerns about whether all schools will receive equal resources and trained staff to implement the changes.

By 2026, the Delhi government aims to cover all government schools, and later extend successful models to aided and private institutions as well.

To meet faculty requirements, the government has approved 1,562 new teaching posts, including 1,065 assistant professors. Until permanent recruitment is completed, teachers will be deputed from existing colleges to prevent disruptions in classroom teaching.

Officials emphasized that the colleges will primarily benefit students underserved and minority-dominated districts, where education higher opportunities are limited.

A senior education official stated:




