Government of India Pushes for Early AI Education: NCERT to Develop AI Textbooks for Classes 11 and 12

NEW DELHI: In a major move to modernize the Indian school curriculum, the Ministry of Education has announced that the National Council of Educational Research and Training (NCERT) is developing dedicated textbooks and syllabi for Artificial Intelligence (AI) for students in Classes 11 and 12.

Key Highlights of the Initiative:

Dedicated Textbook Team: NCERT has constituted a specialized team of experts to design comprehensive learning materials on AI and computational thinking for senior secondary students.

Expansion to Junior Classes: While the focus is currently on Classes 11 and 12, the government plans to roll out AI education across all schools from Class 3 onwards, starting with the 2026–27 academic session.

Early Integration: A vocational project involving AI tools for "Animation and Games" has already been included in the Class 6 curriculum to familiarize middle-schoolers with practical technology applications.

CBSE Role: The Central Board of Secondary Education (CBSE) has drafted a parallel curriculum for Classes 3–12, proposing that AI and computational thinking become mandatory subjects for students in Classes 9 and 10.

Skilling for AI Readiness (SOAR)

To support this digital transition, the government has launched the SOAR (Skilling for AI Readiness) program. This national initiative aims to:

Build Literacy: Create AI awareness among students from Classes 6 to 12.

Train Educators: Strengthen the AI competencies of teachers to ensure effective instruction.

Bridge the Digital Divide: Ensure equitable access to technology education across different geographical regions in line with the Viksit Bharat 2047 vision.

Future-Ready Students

The Ministry of Education emphasized that the move is aimed at equipping the next generation with the technical skills and critical thinking required to thrive in a digital economy. "This initiative is about more than just teaching AI; it's about preparing students for a future where technology plays a central role in every aspect of life," stated an official response.

Program Overview: Animation Film Design

The UG Diploma in Animation Film Design is a comprehensive 24-month (2-year) professional program. Unlike shorter certification courses, this diploma covers the entire pipeline of animation production—from initial conceptualization and hand-drawn storyboarding to advanced 3D character animation and post-production.

Eligibility Criteria

To be eligible for the 2-year UG Diploma, candidates must fulfill the following:

- **Academic Qualification:** Completion of Class 12 (10+2) from a recognized board (CBSE, ICSE, or State Board) in any stream—Science, Commerce, or Arts.
- **Minimum Marks:** Generally, a minimum of 45% to 50% aggregate is required, though this may vary based on the entrance test performance.
- **Aptitude:** A natural inclination toward drawing, storytelling, and digital arts is preferred, as the selection process involves a portfolio review.

Admission Process and Important Dates

The admission cycle for the 2026-2027 academic year follows a multi-step evaluation to ensure candidates possess the creative mindset required for film design.

- **Step 1: Application:** Candidates must register and fill out the online application form on the official IICT portal.
- **Step 2: Entrance Exam (MECAT):** Most IICT-affiliated creative programs require the Media and Entertainment Creative Aptitude Test (MECAT). For the 2026 session, a national-level entrance test is scheduled for January 11, 2026.
- **Step 3: Portfolio Review:** Shortlisted candidates are required to present a portfolio of their creative work (sketches, digital art, or short clips).
- **Step 4: Personal Interview:** A final interview with faculty members to assess the student's vision and commitment to the field.

Core Curriculum and Specializations

The curriculum is split into four semesters, moving from foundational art to complex digital production:

- **Foundation (Year 1):** Principles of Animation, Anatomy and Life Drawing, Storyboarding, Color Theory, and 2D Digital Art.
- **Advanced Production (Year 2):** 3D Modeling (Maya/ZBrush), Texturing and Lighting, Character Rigging, Dynamics, and Visual Effects (VFX).
- **Final Project:** The program culminates in a Capstone Animation Film, where students create an original short film to serve as their professional showreel.

Career Opportunities

Graduates of the 2-year Animation Film Design diploma are prepared for roles such as:

- Character Animator (2D and 3D)
- Storyboard Artist for films and advertising
- Layout and Background Artist
- VFX Compositor
- Game Asset Designer

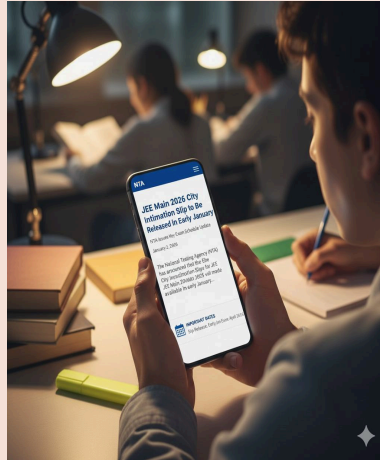
JEE Main 2026 City Intimation Slip to Be Released in Early January: NTA Issues Key Exam Schedule Update

The National Testing Agency (NTA) is set to release the city intimation slip for JEE Main 2026 Session 1 in the first week of January 2026. This slip will inform registered candidates about their exam city and tentative exam date, enabling them to plan travel and logistics well ahead of the examination.

Important Dates & Details:

- City Intimation Slip Release: Expected first week of January 2026.
- JEE Main 2026 Session 1 Exam Dates: January 21–30, 2026 in Computer-Based Test (CBT) mode.
- Admit Card Release: Will be issued 3–4 days before the respective exam date.
- Result Announcement: Session 1 results are slated to be declared by February 12, 2026.
- Session 2 Schedule: Registrations will be held between April 2–9, 2026.



What the Intimation Slip Means:

The city intimation slip is a pre-admit card document that tells candidates which city their exam centre has been allocated in. It does not have the full exam centre address or admit card details, which will be available later when the admit cards are released.

How to Download (Once Available):

Candidates will be able to download the city intimation slip from the official JEE Main portal (jeemain.nta.nic.in) by logging in with their application number and password/date of birth.

Dr.Homi Bhabha Young Scientist Exam Enters Practical Phase

With the Stage 1 (Theory) results declared on December 20, 2025, the focus now shifts to the highly anticipated Practical Competition. Only the top 7.5% of scorers from each region have qualified for this hands-on round.

Countdown: January 2026

- January 4, 2026: Practical Exam (Standard 6)
- January 18, 2026: Practical Exam (Standard 9)
- February 7, 2026: Declaration of Practical Results (Both Standards)

Std 6: Focus on five experiments covering observation, measurement, and basic science skills.

Std 9: Advanced practicals in Physics, Chemistry, and Biology (10 minutes per section).

Next Step: Top 10% from this round move to the Action Research Project (Submission deadline: March 8, 2026).

Grand Finale: Final Interviews are set for March 15, 2026, in Mumbai

CBSE Announces Major Guidelines for 2026 Board Exams for Classes 10 and 12

The Central Board of Secondary Education (CBSE) has released key guidelines and reforms for the 2026 board examinations for Classes 10 and 12, introducing significant changes in exam structure, evaluation and eligibility rules to improve assessment quality and reduce stress on students.

Key Guidelines & Changes:

1. Two-Exam System for Class 10:

CBSE has introduced a twin board exam system for Class 10 students in 2026. If students fail or miss subjects in the first exam, they can appear in the second board exam under the “Essential Repeat” or compartment category or to improve scores.

2. Section-Wise Question Papers for Class 10:

Class 10 papers for Science and Social Science have been reorganised into designated sections. Science is divided into Biology, Chemistry and Physics, while Social Science includes History, Geography, Political Science and Economics; students must answer within the correct sections.

3. Revised Paper Structure:

The board has updated the overall question paper format for both Classes 10 and 12:

- 50% competency-based questions — including case studies, data interpretation, source-based, and situational problems.
- 20% select-response (MCQs).
- 30% constructed-response — short and long answers

4. Mandatory Internal Assessment:

Students must appear in internal assessments/practicals/projects. Those who do not participate will be ineligible for board results, reinforcing the weight of continuous evaluation. These are scheduled January 1 to February 14, 2026.

5. Attendance Rule:

A minimum of 75% attendance in the two-year programme (Classes 9–10 for Class 10 boards; Classes 11–12 for Class 12 boards) is mandatory for eligibility to sit in the examinations, ensuring students attend regular school activities.

6. Exam Schedule:

The board exams are slated to begin on February 17, 2026, with Class 10 exams ending by March 10 and Class 12 exams concluding around April 9. Over 45 lakh students are expected to appear across India and abroad.

New Rules Issued for Maharashtra School Admissions

1. Uniform Age Criteria

To align with the National Education Policy (NEP), the following cut-off rules apply:

- Class 1: Must have completed 6 years of age by December 31, 2026.
- Uniformity: This rule applies to all schools following the state board norms across Maharashtra.

2. Strict Ban on Screening

To reduce stress for young children and parents, schools are strictly prohibited from conducting:

- Entrance Tests for children.
- Interviews of children or parents.
- Screening Procedures at the primary level.

3. Key Objectives

- Ensure a child-friendly and fair admission process.
- Eliminate academic pressure and unfair screening at the entry-level.
- Provide consistency across all state schools for the 2026–27 session.

Note to Parents: These rules are mandatory. Schools found violating the ban on interviews or tests may face action from the department.

NCERT Starts Online Diploma Program in Teaching Science for Classes 6–8

The National Council of Educational Research and Training (NCERT) has officially launched its 40-week Online Diploma Course in "Teaching of Science at Middle Stage" for the 2025–26 academic session. This professional development initiative is designed to strengthen the conceptual understanding and pedagogical skills of teachers handling science for Classes 6 to 8.

1. Key Program Schedule

The program follows a rigorous 40-week timeline to ensure a deep dive into middle-school science education:

- **Program Start Date:** December 29, 2025.
- **Program End Date:** October 18, 2026.
- **Weekly Commitment:** Participants are expected to dedicate 6 to 8 hours per week to complete the course requirements.
- **Format:** The course is conducted fully online through the NCERTX platform (ncertx.in).

2. Program Objectives & Curriculum

Developed by the Department of Education in Science and Mathematics (DESM), the course focuses on moving beyond rote learning toward inquiry-based and student-centered approaches.

- **Core Goals:** To improve classroom transaction of science concepts, promote critical thinking, and align teaching practices with contemporary learning outcomes.
- **Modules:** The curriculum consists of 40 interactive modules. A new module will be opened every Monday and must be completed within that week.
- **Key Topics:** Foundations of science teaching, Physical Sciences (motion, light, electricity), Chemical Concepts (acids, bases, salts), and Life/Environmental Sciences (cells, ecosystems, photosynthesis).

3. Eligibility

- **Target Group:** Primarily aimed at in-service science teachers currently teaching Classes 6, 7, or 8 in both government and private schools following the NCERT curriculum.
- **Fee:** A non-refundable registration fee of ₹2,000 is required.

4. Assessment and Certification

- **Evaluation:** Participants will be assessed through module-wise tests and a final examination at the end of the 40-week period.
- **Certification:** Teachers who successfully complete all academic requirements will be awarded an NCERT e-certificate, validating their enhanced teaching competencies.

ICSI CSEET June 2026 Timetable Released at icsi.edu

The Institute of Company Secretaries of India (ICSI) has officially released the timetable for the Company Secretary Executive Entrance Test (CSEET) June 2026 session. This session marks a significant transition, as it is the first to follow the restructured exam pattern, moving from remote-proctored tests to center-based offline examinations.

Exam Schedule (June 1 – 4, 2026)

The exams follow a single-session timing from 2:30 PM to 5:45 PM (including 15 minutes of reading time).

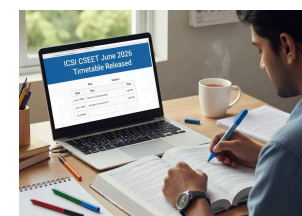
- June 1: Business Communication (Subjective)
- June 2: Fundamentals of Accounting (Subjective)
- June 3: Economic and Business Environment (Subjective)
- June 4: Business Laws and Management (OMR-based/Objective - ends at 4:45 PM)

Registration & Enrollment Deadlines

- June 2026 Registration: Open from December 16, 2025, to February 15, 2026.
- Registration Fee: Revised to ₹7,500.
- Exam Enrollment: March 1 to April 7, 2026 (Regular fee of ₹1,500).

Passing Criteria

To qualify, candidates must secure a minimum of 40% marks in each paper and an overall aggregate of 50% in a single sitting.

Selection Process: The Two-Stage Approach

Admissions are based on a holistic assessment rather than just academic grades.

1. The Entrance Test (APU NET)

The test is designed to measure aptitude and perspective. It typically lasts 3 hours and includes:

- Part A (Multiple Choice): Covers Reading Comprehension (analyzing complex texts), Quantitative Reasoning (logic and basic math), and Domain-Specific questions (Humanities, Social Sciences, or Sciences based on your major).
- Part B (Descriptive): A writing section where you respond to a prompt. This evaluates your ability to build logical arguments and express your views on social issues.
- Note: There is usually no negative marking for undergraduate entrance tests.

2. The Personal Interview

Shortlisted candidates move to the interview stage, which is the most critical part of the selection.

- Format: Interviews are conducted either online (via video call) or in person at the respective campuses. The university usually allows candidates to choose their preferred mode.
- Focus Areas: The faculty panel looks for social awareness, your motivation for choosing a liberal education, and your alignment with the university's values of equity and justice.

Special Admission Route: BSc BEd

If you are applying for the Integrated BSc BEd at the Bangalore campus, the process is different. Admissions are not through APU's NET. Instead, you must qualify for the NCET-ITEP (National Common Entrance Test) conducted by the NTA. You must register on the NTA website separately.

Preparation Strategy

- Critical Reading: Regularly read long-form essays or editorials from The Hindu or The Indian Express to prepare for the comprehension and interview stages.
- Practice: Utilize the sample question papers available on the [APU website](#) to understand the unique "aptitude-based" style of the exam.
- Financial Aid: APU offers extensive need-based scholarships. If you require financial assistance, keep your family's income documents ready during the application phase.

MAH MCA CET 2026 Registration Starts January 1, 2026

The MAH MCA CET 2026 is the mandatory state-level entrance exam for admission into Master of Computer Applications (MCA) programs across Maharashtra. For the 2026-27 academic session, the State Common Entrance Test Cell has introduced significant updates regarding mandatory identification and registration protocols.

Mandatory Registration Requirements

This year, the CET Cell has made two specific digital IDs compulsory for all applicants. Candidates are advised to generate these before beginning their application to avoid technical blocks:

- Aadhaar Authentication: All candidates must have a valid Aadhaar card. The registration process will include an Aadhaar-based verification step.
- APAAR ID: The Automated Permanent Academic Account Registry (APAAR) ID is now a prerequisite. This "One Nation, One Student ID" serves as a lifelong digital identity for students, storing academic data and credits.

Important Dates for 2026

The admission cycle follows a strict timeline. While the exact closing date often falls in the second week of February, students should aim to complete their forms well in advance.

- Registration Launch: January 1, 2026
- Final Date for Application: Second week of February 2026
- Entrance Examination: March 30, 2026

Eligibility and Application Fees

To be eligible for the exam, candidates must be Indian nationals and hold a Bachelor's degree (minimum 3 years) from a recognized university. A key academic requirement is having studied Mathematics at the 10+2 level or during graduation.

- General Category: INR 1,200 (includes Outside Maharashtra State/OMS and J&K Migrant candidates).
- Reserved Categories: INR 1,000 (applies to SC, ST, OBC, EWS, and PwD candidates belonging to Maharashtra State only).
- PwD Requirements: Candidates with disabilities must upload a valid Unique Disability ID (UDID) or an official disability certificate at the time of registration.

Step-by-Step Registration Process

The entire process is conducted online via the official portal at [cetcell.mahacet.org](#). Candidates should follow these steps:

1. New Registration: Click on "New Candidate Registration," enter basic personal details, and verify your account via OTP sent to your mobile and email.
2. Aadhaar & APAAR Verification: Complete the mandatory authentication using your Aadhaar and APAAR ID credentials.
3. Details & Preference: Fill in academic qualifications and select your preferred exam centers (test cities).
4. Document Upload: Upload a scanned recent passport-size photograph (20-50 KB) and a signature (10-20 KB) in JPG/JPEG format.
5. Payment: Pay the application fee through the integrated online payment gateway (Credit/Debit Card, Net Banking, or UPI).
6. Confirmation: Download and print the submitted application form and fee receipt. These are essential for the Centralized Admission Process (CAP) later.

Exam Pattern Highlights

The MAH MCA CET is a computer-based test (CBT) lasting 90 minutes. It consists of 100 Multiple Choice Questions (MCQs) worth 2 marks each, totaling 200 marks.

- Sections: Mathematics & Statistics, Logical/Abstract Reasoning, English Comprehension & Verbal Ability, and Computer Concepts.
- Marking: There is no negative marking for incorrect answers.

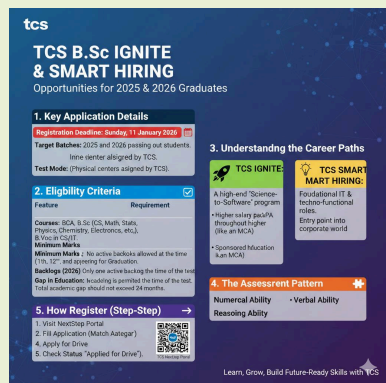

Geo-Tagging Deadline For Schools (Classes 1-12)

The Maharashtra State Education Department has issued a final, strict deadline for the mandatory geo-tagging of all schools (Classes 1-12) and Anganwadis across the state. This process is part of a larger digital transformation initiative under the NEP 2020 structural guidelines to create a verified, transparent map of educational infrastructure.

Key Deadlines and Statistics

- Final Deadline: January 4, 2026.
- Status Update: Out of the 1,08,165 total schools in the state, 1,04,367 schools have successfully completed the process.
- Pending Schools: Approximately 3,798 schools are still remaining.
- High Pendency Districts: Chhatrapati Sambhajnagar: 477 schools
 - Mumbai Suburban: 437 schools
 - Nagpur: 403 schools
 - Yavatmal: 326 schools
 - Pune: 90 schools

How the Geo-Tagging is Conducted

The process must be completed using the Mahaschool GIS Mobile Application, developed by the Maharashtra Remote Sensing Application Centre (MRSAC).

- On-Site Presence Required: The Headmaster or a designated official must be physically present on the school premises to capture data.
- Data Points: The app records the exact latitude and longitude (GPS coordinates) of the school.
- Photographic Evidence: Schools must upload real-time, time-stamped photographs of school buildings and physical facilities.
- Integration: The submitted data is auto-populated and integrated with the central government's UDISE+ portal.

NIFT Exam Registration Date Extended

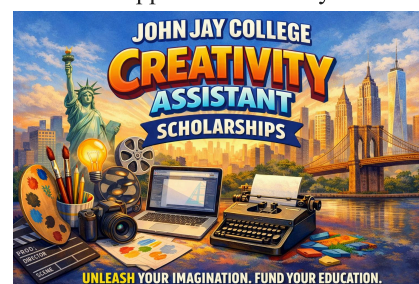

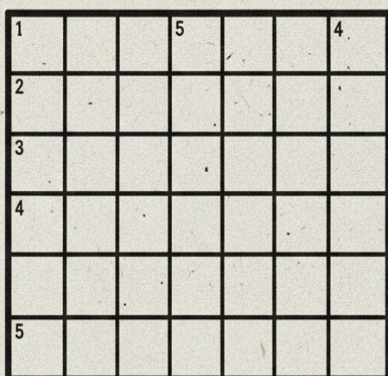

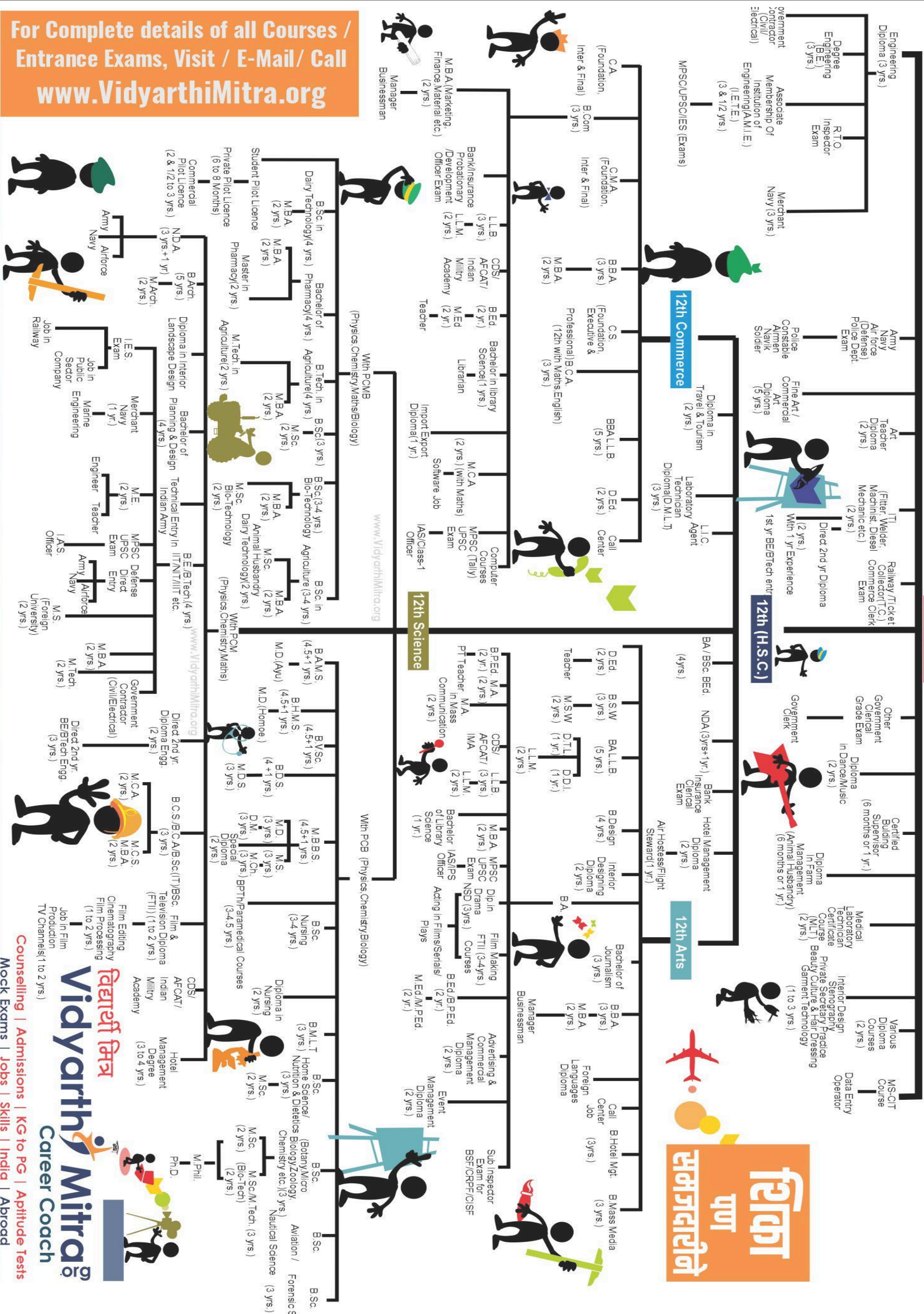
